### 1. Apologies

Resolved to note that apologies for absence had been intimated on behalf of D Scarth and Councillors H Johnston and R King.

### 2. Police Scotland Matters

Resolved to note that there were no Police Scotland matters to report at this time.

# 3. Minute of meeting held on 23 August 2018

The Minute of the meeting held on 23 August 2018 was considered by members, and subsequently approved, being proposed by R Delday and seconded by S Spence.

# 4. Matters Arising

### A. Chairman's Gratuity

The Interim Clerk informed members that the £1,100 previously approved and paid to the Chairman in recognition of extra time and work involved with the position had been returned by the Chairman and had been repaid into the Community Council General Fund, and it was:

Resolved to note the information provided.

### B. Replacement Sign at Fisherman's Huts

Members were advised that the replacement sign had been obtained, and it was:

Resolved that R Rendall would erect the replacement sign, with M Hay advising him on the exact location.

### C. Foreshore from Ministry Huts to Zanzibar

The Chairman informed members that he had been advised that in order to obtain external funding to develop the foreshore a lease would be required, rather than permission from landowners and, after discussion, it was resolved:

- 1. That the Chairman would obtain quotes for the proposed developments.
- 2. That the proposals would be discussed further at the next meeting.

### D. Slip at Buckquoy

Following consideration of an update provided by Councillor King informing members that the Executive Director of Development and Infrastructure had been in contact

with Historic Environment Scotland regarding the condition of the Slip at Buckquoy, it was:

Resolved that the Chairman would contact Historic Environment Scotland directly in this regard.

# E. Repair to Kirkyard Shed

Following discussion, it was resolved:

- 1. To note that A Norquoy had repaired the shed.
- 2. That M Hay would place a barrel next to the shed.
- 3. That the Chairman would fit a tap and pipework to the barrel.

### F. Proposed Costa Head Wind Farm – Community Investment

The Chairman informed members that he had spoken to Local Energy Scotland who had advised that the Community Council should not proceed until after the planning appeal. He had also spoken to South Ronaldsay and Burray Community Council and would contact them further should the appeal be successful, and it was:

Resolved to note the information provided.

### **G. Roon Aboot Birsay Newsletter**

The Chairman informed members that he was still the editor of the newsletter but hoped that another member would soon take over and, after discussion, it was:

Resolved to ask the Mums and Toddlers group to distribute the newsletter.

### H. Forst, The Palace

The Chairman informed members that he had spoken to the owner of Forst regarding access to the car park for the purpose of taking her wheelie bin to the roadside, and it was:

Resolved that the Interim Clerk would write confirming that Birsay Community Council had no objections to the proposals, but the bin must not be left in the car park or at the car park gate.

### I. Birsay Playpark

M Hay informed members that he had spoken to the Birsay Hall Committee and they had agreed to give £20 each. It was recognised that G Flett and S Wylie had put a huge amount of work into the Playpark, and it was:

Resolved that the Chairman would speak to S Scarth about putting a thank you message in the Birsay Newsletter.

Resolved not to donate to THAW Orkney at this time.

#### B. ADNA Festival Aberdeen

Correspondence had been received from M Shoesmith requesting funding towards the cost of her daughter travelling to Aberdeen for the U13 ADNA festival with Orkney Netball, and it was:

Resolved that a donation of £30 be given towards the cost of the trip, to be met from the General Fund.

### C. Police Scotland Emergency Services Fun Day

Following consideration of correspondence from Police Scotland Youth Volunteers requesting funding for an Emergency Services Fun Day, to be held early in December, it was:

Resolved that a donation of £100 be given towards the Orkney Drug Dog, to be met from the General Fund.

### A. Crown Estate

Members were informed that Orkney Islands Council had been included in a pilot scheme to take ownership of the seabed to the twelve-mile limit, and it was:

### **B. Birsay Hall**

Birsay Hall Committee had asked for help with the cost of grass cutting at the play area, and it was resolved:

- 1. That S Spence would find out the additional cost for grass cutting of the play area.
- 2. To resume consideration of this item at the next meeting.

#### C. Fisherman's Hut

Members were advised that Birsay Heritage Trust had agreed to share the cost of repairs at the Fisherman's Hut, and it was:

Resolved that the Chairman would arrange for the repairs to be carried out.

### **D. Dounby Bus**

Members were informed that the Dounby Centre were seeking funding for the Dounby Bus and that they would be approaching Harray and Sandwick Community Council for a donation, and it was:

Resolved to note the information provided.

### **E. Christmas Tree Lighting Ceremony**

Consideration was given to the arrangements for the Christmas Tree Lighting Ceremony to be held on Friday, 7 December 2018, and it was resolved:

- 1. To note that the tree would be erected on Wednesday, 5 December at 18:30.
- 2. That the youngest child at Dounby Community School and a resident of Smiddybrae would be invited to turn on the Christmas Tree lights.

- 3. That Birsay Community Council would provide four of the eight wardens required for the event.
- 4. To note that monies collected at the event would be donated to Malawi towards digging of wells for fresh water.
- 5. To note that Birsay Community Council would be paying a share of the costs of the event, namely hiring a lorry and purchasing selection boxes and Santa presents.
