The Chair advised members that he had contacted the previous Chair regarding the proposed project however he was waiting for some of the information still, and it was:

B. Slip at Buckquoy

Members heard a report from the Chair advising that more land had fallen at the top of the slip and that a hole had almost eroded through under the concrete at the lower end of the slip, which could be a danger to the public. Members discussed previous contact between Orkney Islands Council and Historic Environment Scotland regarding repairs to the slip, and it was:

Resolved:

- 1. To write Orkney Islands Council advising on the condition of the slipway.
- 2. To contact Historic Environment Scotland to ascertain their input into the work.

C. Draft Plan for Dounby

Following consideration of correspondence from Democratic Services advising members that the Dounby Village Plan had been placed on hold meantime due to Covid-19 and that it would be hoped to continue the project in early 2021, it was:
