# 1. OWNP Update

The Community Engagement Manager, Orkney Native Wildlife Project, gave an update on the stoat eradication program in the Birsay parish, and throughout Orkney. He explained that the program was now in the "knock down" phase, where responses were made to individual sightings, as the population of stoats was now at such low levels to enable this.

- Stoats caught in Birsay area 572 with 1119 traps deployed. 1,200 Rats removed.
- Total stoats caught 6,022 in the county.
- Total traps deployed 7,932.
- 105 volunteers currently active.
- So far, volunteers have given 16,415 hours.
- 65 talks with local groups and councils. 12 Tourist provider training events. 43 biosecurity events. 4 volunteer trapper training events. 58 monitoring volunteer training events, and 10 agricultural shows.

The Community Engagement Manager completed his talk, and answered a number of questions, and it was:

Resolved to note the update.

# 2. Quiet Routes

The Senior Project Officer, SUSTRANS introduced the Quiet Routes pilot project, which would identify stretches of roads which would fit the funding criteria. Data had been collected to identify the safest and quietest routes, which would be highlighted to drivers by means of signage. After discussion, a number of routes were proposed around the Birsay area. Members were encouraged to have a look at the map provided and forward any suggestions on before the end of March. Examples of signage would also be circulated, and it was:

Resolved that members were to forward on any suggestions for a quiet route before the end of March, and examples of signage would be circulated to members.

#### C. Treatment of Causeway

The Chair stated no update had been received, but hopefully this will still be considered, as it is a core path, and it was:

#### D. A Poke – Whitemire Farm Track

The Chair stated that he was contacted by A Poke, concerning the condition of the track, as it was used regularly by bird watchers at Swannay Loch. The Empowering Communities Liaison Officer offered to check if the track lies within the Birsay Parish, and report back to members so a decision could be made, and it was:

Resolved that the Empowering Communities Liaison Officer would check if the track lies within the Birsay Parish and report back to members.

## E. Quilco Path

The Clerk reported that contact had been made with SUSTRANS and that there was a possibility of funding from the Ian Findlay Path Fund. This was being discussed at the Harray and Sandwick Community Council meeting on 13 March, and Birsay Community Council members were invited to attend, and it was:

## **B. R100 Scottish Broadband Voucher Scheme**

Members considered correspondence from Orkney Islands Council, inviting the community council members to promote The Scottish Government's Reaching 100% (R100) programme which ensures that all premises in Scotland can access superfast broadband – speeds of at least 30 Megabits per second. It was advised that the £600m broadband infrastructure programme included the R100 contracts, which would see over 3,318 homes and business in Orkney benefit from full fibre, which was over 30 times faster than the original commitment. The Head of Property, Asset Management and Facilities stated that this scheme is designed to cover where Openreach were not providing a service, and it was:

Resolved to note the contents of the correspondence.
