1. Apologies

Resolved to note that apologies had been received from Councillor H Johnston, Councillor D Tullock and Mr V Muir.

2. Orkney Island Council Representatives for the Quanterness Proposal of Application Notice Presentation

Members were given a presentation from three representatives of Orkney Island Council regarding the wind turbine proposed site, with the following elements discussed:

- The aims of the project.

- · Siting of Quanterness turbines and why.
- Consultation process.
- Engagement with communities.
- Specifically, 4 question but any questions were welcomed.
- Dissemination of information attained.
