1. Apologies

Resolved to note that apologies for absence had been received from Mr D Marwick, Mr K Thomson and Councillors Cowie, Foulkes and Richards.

2. Adoption of Minutes

The minute of the meeting held on 21 November 2019 was approved, being proposed by Mr A Dundas and seconded by Mr M Clouston.

3. Matters Arising

A. Bus Shelter Germiston Road

The Interim Clerk advised members that the issue of land ownership has not yet been finalised and that he would report back once all the relevant checks had been carried out. Members were also advised that OIC have no objection in principle for a cycle shelter to be used as a bus shelter at this location, but that currently there were no spare shelters or funding available for this, and it was:

Resolved:

- 1. To note the information provided.
- 2. That the Interim Clerk would continue to chase OIC for confirmation on the land ownership situation.
- 3. To keep this item on the Agenda for further discussion at the next meeting.

B. Scapa Bends

Members were advised that a letter had been sent to Scapa Distillery asking for assistance regarding the possible maintenance of the Core Path and surrounding area, and that a reply was now awaited. Following further discussion, members all agreed that a solution was required from a road safety perspective. The Interim Clerk also confirmed that Kirkwall and St Ola Community Council had indicated their support to members' proposals regarding the Verge Maintenance Plan for this area, and it was:

Resolved to note the information provided.

C. Road at West Cottage

Members considered correspondence from Democratic Services dated 10 January 2020 confirming that OIC had been asked to make contact direct with the landowner in order to find a suitable solution to this issue. Members expressed their frustration at the lack of movement and agreed that this was a road safety concern that would

need to be addressed as a matter of urgency. Following further discussion and suggestions, it was:

Resolved:

- 1. That Councillor Manson was to discuss this issue further with Councillor Cowie and the Roads Department and report back to Democratic Services.
- 2. To keep this item on the agenda for further discussion at the next meeting.

D. School Bus Route
