C. Two Hockey Trips to Shetland

D. Doors Open Day

I. Kirkwall and St Ola Community Council - 2019 Bonfire and Fireworks Display

1. That following a report from Councillor N Craigie on the subsidence at Churchyard Road, Tankerness, where remedial works to skim and resurface this section of the road would be carried out in the future and that at present OIC did not deem this issue a priority matter, it was:

2. That all the boxes of the current East Mainland Tourist Leaflet (EMTL) had been distributed to Visit Scotland and the Italian Chapel, and it was:

Resolved that a new print of EMTL's was required to be progressed.

- 3. Mrs G Barnby was attempting to progress a bus pick-up point for the fourteen KGS pupils at the St Andrews Primary School, in an attempt to avoid the congestion in the morning at the junction of the Quoybrae housing development in Toab. Following discussion, it was resolved:
- A. That Councillor N Craigie would make contact with the new Head of Education Leisure and Housing to ascertain if the KGS bus could pick-up the KGS pupils at St Andrews Primary School in the morning instead of at the Quoybrae housing development junction until a suitable solution can be found.
- B. That the Clerk add this issue to the Live List.
- 4. Mrs L McAdie advised that the new print of the EMTL was continuing to progress, with another meeting with Holm, and South Ronaldsay and Burray Community Council's to be arranged shortly, and it was:

Resolved to note the information provided.

5. Mr W Bruce advised that he had experienced two road safety issues on the Kirkwall/Stromness Road that was causing motorists concern and difficulty. These issues were caused by groups of cyclists and need to be addressed with some urgency before there was a serious accident. Mr D Alexander also advised that on the main Kirkwall/Stromness Road there were no passing places to allow slow moving equipment e.g. agricultural vehicles to come off the road to allow traffic to pass and avoid congestion. Following discussion, it was:

Resolved that the Clerk report these issues to Police Scotland, Democratic Services and Councillor A Drever.
