1. Apology

Resolved to note that apologies for absence had been intimated on behalf of G Deans.

2. Police Matters

The police representative was unable to attend the meeting. However, he had forwarded the following update:

- The Orkney Drug Dog continued to work well in the local community.
- The PSYV (Police Scotland Youth Volunteers) was still going strong with high level of regular attendance. They had recently supported police with leaflet drops in areas regarding ongoing enquiries.
- Northern Division of Police Service of Scotland would soon be taking up the use of Mobile Working. Officers would be using mobile devices as part of their operational duties.

Resolved that the information be noted.

3. Adoption of Minutes

The minute of the meeting held on 25 June 2019 was approved, being proposed by E Knight and seconded by W Mackay.

4. Matters Arising

A. Market Green Fencing Stabs

Following consideration of correspondence received from the Sport and Leisure Service Manager, copies of which had been circulated, regarding safety concerns raised in connection with the some of the fencing stabs, it was:

Resolved to note that the Active Schools Co-ordinator had advised that the condition of the posts and fence would be monitored and if safety concerns were found, work would be carried out to resolve them.

B. Jack Renton - Proposed Plaque

After consideration of correspondence received from Democratic Services in connection with the proposed erection of a plaque, and following discussion, it was:

Resolved to note:

- 1. That the Planning Manager, Orkney Islands Council, had confirmed that the property where the proposed plaque was to be erected was a Listed B building.
- 2. That a Listed Building Consent application and Advertisement content required to be submitted for the erection of the plaque.
- 3. That there was no fee for Listed Building Consent, however, there may be a fee for Advertisement Consent.

- 4. That the Clerk would investigate the standard plaque size and get quotes for the cost.
- 5. That the wording for the plaque that had been agreed at the meeting held on 25 June 2019 should follow the same format as other plaques, such as Eliza Fraser's.

C. Financial Requests – Orkney Yole Association

- 3. That the grant awarded was in respect of the following qualifying category:
- Costs associated with publishing a book on Orkney Yoles. Evidence of costs must be provided once the book is published.

D. Campsite Sign at Foot of Back Road

One attached to the wall on the Back Road, with the other on North End Road attached to a lamp post pointing towards the Back Road. The Development Officer confirmed that the playpark at Guardhouse Park was now underway. Funding for bushes for the park had been applied for.

Regarding the Christmas lights – the final decision was still to be made on the proposal submitted by Colin Begley. It was hoped that some of the new lights would be in place for Christmas 2019, and it was:

Resolved to note the information provided.

D. Playpark Sub-committee

The Playpark Sub-committee representative confirmed work on the new playpark had now begun, and it was:

Resolved to note the information provided.

11. Financial Statements

A. General Finance

After consideration of the General Finance statement as at 14 August 2019, it was:

Resolved to note that the balance was £8,859.49.

B. Sea Haven Account

After consideration of the Sea Haven Account statement as at 14 August 2019, it was:

Resolved to note that the balance was £9,824.62 of which:

- £3,607.90 would be held to be released once the Christmas lights had been purchased for the town.
- £5,000 which was ring-fenced for redevelopment of the playpark at Guardhouse Park.
- £100 which had been donated from Stromness Drama Club towards purchasing a new flag but as the money was not ring-fenced if replacing the flag did not go ahead the money would be put towards another worthwhile community project.
- £1,050.72 to be solely used for the upkeep and maintenance of the stage.

C. Community Council Grant Scheme

Resolved to note the balance remaining for approval was £720.40.

B. Orkney Amateur Football Association - 101 Milne Cup - Shetland

- 2. To note that it should be emphasised to the organisations requesting to use the canopy that the canopy was heavy and therefore strength was needed when volunteering to erect and dismantle it.

C. GMB Garden

A member informed the meeting that weed killer was required for the GMB Gardens, and it was:

Resolved to note the information provided.

D. Wall at John Street

A member enquired what was happening regarding the wall that had been damaged recently by a car on John Street. Councillor Stockan confirmed that the damage

sustained had proved challenging and would require an engineer's study in order to fix the damage, and it was:

Resolved to note the information provided.

E. Trees/Shrubs - Outertown Road

A member raised safety concerns regarding trees/shrubs encroaching the road from a property on the Outertown Road, and it was:

Resolved that Councillor Crichton would consult with the relevant department of the Council regarding this matter.

F. Catering Van - Stromness Bonfire

A member had been approached by the owner of a fast food outlet whether they could attend Stromness Bonfire and, following discussion, it was:

Resolved:

- 1. That J Park should contact the owner of the fast food outlet let them know that Stromness Community Council had no objections to them attending.
- 2. That should the fast food outlet that had attended last year wish to return, both owners should be notified of the others intended presence at the event.

G. Former Stromness Primary School Gardens

A member commented on the poor state of the former Stromness Primary School Gardens, and it was:

Resolved to note the information provided.

H. Eventide Club Doors

A member commented on the poor state of the Eventide Club doors, and it was:

Resolved that Councillor Crichton would bring this to the relevant section of the Council's attention.

I. New Names for former Stromness Primary/Old Academy

Councillor Stockan informed members of the proposed new names for the former Stromness Primary/Old Academy buildings and requested that if there was any strong objection to let him know so he could feed it back, and it was:

Resolved to note that Stromness Community Council had no objections to the proposed names for the buildings.
