# 1. Presentation by the Roads and Environmental Services Manager

The Roads and Environmental Services Manager raised and discussed issues requiring members' help and input, and it was:

Resolved:

A. That the Roads and Environmental Services Manager would consult the island's resident Roads Operative about the positioning and manoeuvring of the recycling skip into a new location in Wood Yard.

B. That the Roads and Environmental Services Manager would follow up members' suggestion of a possible site for relocating the roads depot.

C. That the Roads and Environmental Services Manager would approach the landowner of a site members identified for the temporary storage of material required for road surface dressing.

D. That the Roads and Environmental Services Manager would ask for coastal erosion in Mill Bay and on the sea wall near Mount Pleasant to be investigated.

E. That the Roads and Environmental Services Manager would liaise with the Operations Planner regarding a commencement date and programme of work for repairs to the Rothiesholm beach car park and would forward any information on this to the Community Council Liaison Officer.

F. To note that catch-up work would be undertaken to clean ditches and gullies this year.

The Chair thanked the Roads and Environmental Services Manager for his participation.

The Roads and Environmental Services Manager left the meeting at this point.

## 2. Apologies

Resolved to note that apologies for absence had been received from Mr D Stout.

## 3. Adoption of Minute

The minute of the meeting held on 3 March 2021 was approved, being proposed by Mrs S Whiteman and seconded by Mr J Seaton.

## 4. Matters Arising

#### A. Village Play Park

Members heard that two members had yet to see and comment on the two outdoor play equipment brochures that had been circulating, and it was:

Resolved:

1. That members would check to see if the catalogues were still in their possession.

2. That, if the catalogues could not be located, new ones would be requested.

#### B. Bay Kirkyard – Ground Levelling Request

Members heard that the Strategic Policy and Projects Manager had been contacted regarding members' request for the uneven ground in the Bay Kirkyard to be levelled, and that members would be informed of any update when available, and it was:

Resolved:

1. To note the information.

2. That the Community Council Liaison Officer would contact the Roads and Environmental Services Manager and request the uneven ground in the Bay Kirkyard be looked at when a representative from the department visits Stronsay.

#### C. Ferry Cafeterias

Members heard that since the last meeting a response had been received from a North Isles Community Council on the non-availability of a cafeteria service on the inter-island ferry services and that this had been emailed to members. Members also heard that it was anticipated things would return to normal as COVID levels decreased and that the ferry cafeterias would reopen and, following discussion, it was:

Resolved to note the information.

#### D. Rothiesholm Beach Car Park

Members heard that the Chair had undertaken a site visit with the Roads Services Technician whose report on the Rothiesholm beach car park had been emailed to members. Work was to proceed but it was not known when, and this had been brought to the attention of the Roads and Environmental Services Manager earlier in the meeting, and it was:

Resolved to note the information.

#### **E. Grass Cutting Contracts**

Members heard that they had previously been consulted and agreed to award the 2021 grass cutting tenders, and it was:

Resolved to note the information.

#### F. Bay Kirkyard Issue – Rabbit Burrowing

Members heard that the Strategic Policy and Projects Manager had been contacted regarding members' concern over rabbit burrowing in the Bay Kirkyard, and that members would be informed of any update when available, and it was:

Resolved to note the information.

#### G. New Cemetery Car Park

Members heard that their request for the removal of weeds in the new cemetery car park was in hand and that this might have already been completed, and it was:

Resolved to note the information.

#### H. Stronsay Bird and Seal Hide Tenders

Members heard that they had previously been consulted and agreed to award contracts to repair the Stronsay bird and seal hides. Liaison had taken place with the Project Officer, North Isles Landscape Partnership, and it was:

Resolved to note the information.

## I. Community Council Grant Scheme – Carry Over of Unallocated Funds

Members heard that no special conditions had been placed this year to allow Community Councils to carry over Community Council Grant Scheme unspent capping limit, or provide a higher limit, and it was:

#### J. Islands of Orkney Brochure 2021

Members heard that they had previously been consulted on the Islands of Orkney Brochure 2021 and that notices had been displayed regarding any additions or deletions required for Stronsay's section, and that these had been forwarded for amendment, and it was:

## 5. Stronsay Slaughterhouse Report

Members heard that a blocked drain at the slaughterhouse had been cleared and that they had previously been notified of the slaughterhouse usage between April 2020 and March 2021. Members also heard that the slaughterhouse electricity supplier had provided details of an electricity rate change, and it was:

Resolved to note the information provided.

#### 6. Fish Mart Report

Due to the sensitive nature of this item, the following was taken in private.

Operational issues were discussed and noted. Members also heard that they had previously been consulted and agreed to a request from the Operator to provide financial assistance towards the additional cost incurred in providing COVID-19 cleaning materials. No further information was available on members' request for redecoration and improving the fabric of the building, addressing the heat loss issue in café's vaulted ceiling or on when an extractor fan would be fitted in the café's freezer room. The coin-operated shower unit had been fitted in the public shower

room and an update was given on the cost of installing a wind turbine to help heat the building and reduce hydro costs, Councillor Sinclair had contacted ReFLEX Orkney but had nothing definite to report, and the Clerk had received advice from Voluntary Action Orkney on alternative cost reducing possibilities, and it was:

Resolved:

A. To note the information provided.

B. That no further action would be taken on installing a wind turbine to help supplement the building's heating provision.

C. That a further request would be made to address the heat loss issue in the café's vaulted ceiling and in improving and redecorating the fabric of the building.

D. That further enquiries would be made on cost reducing possibilities in heating the Fish Mart.

### 7. Stronsay Development Trust – Co-opted Representative's Report

Members were given a verbal summary of the Stronsay Development Trust's recent activities and projects, and consideration was given to a request for a member to join a newly formed Waste Recycling Committee, and it was:

Resolved:

B. That Mr P Riley would represent the Community Council on the Waste Recycling Committee.

#### **D. Village Play Park Fence**

Members heard that the several fence posts dividing the village play park and the adjoining field had rotted and were in need of attention and, following discussion, it was:

Resolved:

1. That clarification would be sought on whose responsibility it was to maintain the village play park fence.

2. That the Clerk would take and forward photographs of the damaged posts.

#### E. Vat o' Kirbuster Bench

Members heard that the bench had not yet been positioned at the Vat o' Kirbuster, despite both verbal and written communications having taken place with the successful bidder, and it was:

Resolved that the Clerk would write to the successful bidder again advising that if work was not completed by 31 May 2021 the project would readvertised.
