1. Suspension of Standing Orders

2. Form of Voting

3. Disclosure of Exempt Information

The Committee noted the proposal that the public be excluded from the meeting for Item 4, as the business to be discussed involved the potential disclosure of exempt information of the classes described in the relevant paragraphs of Part 1 of Schedule 7A of the Local Government (Scotland) Act 1973 as amended.

4. Taxi Driver's Licence

Councillor Robin W Crichton declared a non-financial interest in this item, being the holder of a taxi driver's licence, but concluded that his interest did not preclude his involvement in the discussion.

Councillors Norman R Craigie and Steven B Heddle declared non-financial interests in this item, in that the licence holder was known to them, and left the meeting at this point.

On the motion of Councillor Duncan A Tullock, seconded by Councillor Alexander G Cowie, the Committee resolved that the public be excluded from the meeting for this item on the grounds that it involved the disclosure of exempt information as defined in paragraphs 6 and 14 of Part 1 of Schedule 7A of the Local Government (Scotland) Act 1973 as amended.
