Combined Annual Functions and Financial Report

- **2.1.** That, with effect from 15 May 2017, licensing boards were required to publish an annual financial report in relation to the exercise of their functions in terms of the Licensing (Scotland) Act 2005, within 3 months of the end of the relevant financial year.
- **2.2**. That, with effect from 20 December 2017, licensing boards were required to publish an annual functions report in terms of the Licensing (Scotland) Act 2005, within 3 months of the end of the relevant financial year.

4. Papay Community Co-operative Ltd

Application for Variation of Premises Licence

After consideration of a report by the Clerk to the Board, copies of which had been circulated, the Board:

Noted:

- **4.1.** That a premises licence had been held at Beltane House, Papa Westray, since 1 September 2009, by Papay Community Co-operative Ltd.
- **4.2.** That Papay Community Co-operative Ltd had submitted an application for a variation of premises licence held in respect of Beltane House, Papa Westray, which sought the following:
- An increase in off-sale display capacity of 2.4 square metres, from 3.3 square metres to 5.7 square metres.
- Provision of activities of theatre and televised sport within the premises for the first time.
- **4.3.** That no objections or representations had been received in respect of the application from Papay Community Co-operative Ltd for a variation of the premises licence in respect of Beltane House, Papa Westray.
- **4.4.** That, although Alan Sharp, representing Papay Community Co-operative Ltd, had advised that he intended to be present during consideration of this item, due to circumstances outwith his control in that internal air services were not operating due to adverse weather, he was unable to attend.

The Board resolved:

- **4.5.** That the application from Papay Community Co-operative Ltd for a variation of the premises licence in respect of Beltane House, Papa Westray, be granted, as follows:
- Off-sale display capacity increased by 2.4 square metres, from 3.3 square metres to 5.7 square metres.
- Provision of activities of theatre and televised sport within the premises.
