Subject: Chair's Report – Clinical and Care Governance Committee.

1. Summary

1.1. This report highlights key agenda items that were discussed by the Clinical and Care Governance Committee at its meeting on 22 May 2018 and it was agreed that these should be reported to the Integration Joint Board and NHS Orkney.

4. Key agenda items

4.1. Delayed Discharges

4.1.1. Members were advised of the current favourable delayed discharge position and although there were variances in Home Care, needs were being managed and there was currently no waiting list for Residential Care.

4.1.2. Members were advised that although there were vacancies in the Home Care service, these were being managed well and data would be captured through the Allocation and Resource Committee.

4.2. Joint Investigation Interview for Children and Young People

4.2.1. Members raised significant concerns around the proposed changes to the Joint Investigative Interviews of children and young people and how this could negatively impact on children and young people locally. The direction of travel being

set out was to create a more centralised highly specialised and trained teams of investigative interviewers as opposed to the current established generalist approach.

4.2.2. A number of areas of discussion emerged in relation to Orkney having enough demand to sustain this higher level of specialism and if not, the impact of any such team being based in Inverness and the impact of this on children and young people and the subsequent resourcing issues. Representation would be made to Social Work Scotland to explore options for this to topic to be considered within any island proofing discussions

4.3. Chief Social Work Officer's Quarterly Report

4.3.1. Members were advised that the Chief Social Work Officer had undertaken a review of professional governance.

4.3.2. Members were presented with a proposed new governance structure which would have one overarching Social Work and Social Care Governance Group and two sub groups: Improvement Group – Adults and Improvement Group – Children.

4.3.3. Members agreed that the proposal would strengthen the governance arrangements.

4.4. Autism Diagnosis Pathway

4.4.1. Members were advised that the short life working group had met for its final meetings with the pathway now in place. Electronic copies of the pathway would be available in due course.
