# **Integration Joint Board**

Subject: Orkney Community Justice Outcomes Improvement Plan 2018-21.

#### 1. Summary

1.1. This report introduces the Orkney Community Justice Outcomes Improvement Plan 2018-21.

# 2. Purpose

2.1. This report is for noting the work of the Orkney Community Justice Partnership, and approving in principle the contribution to be made by services within the strategic planning remit of Orkney Health and Care to the Orkney Community Justice Outcomes Improvement Plan 2018 - 2021.

#### 3. Recommendations

The Integration Joint Board is invited to:

- 3.1. Note the content of the Orkney Community Justice Outcomes Improvement Plan 2018 2021,
- 3.2. Approve the contribution to implementation of the Plan to be made by services within the strategic planning remit of Orkney Health and Care.

# 4. Background

- 4.1. The Orkney Community Justice Partnership was established in April 2017, in line with the disestablishment of regional Community Justice Authorities on 31 March 2017, and establishment from 1 April 2017 of local Community Justice Partnerships under the provisions of the Community Justice (Scotland) Act 2016. The Act states "The community justice partners for the area of a local authority must, in accordance with such provision as to timing as the Scottish Ministers make by regulations, publish a plan in relation to community justice for the area". The Act identifies the following Community Justice Partners acting jointly:
- The local authority for the area.
- The health board for the area, or within whose area the area of the local authority falls.

- The chief constable of the Police Service of Scotland.
- The Scottish Fire and Rescue Service.
- Skills Development Scotland.
- Any integration joint board established by virtue of section 9 of the Public Bodies (Joint Working) (Scotland) Act 2014 for the area, or within whose area the area of the local authority falls.
- The Scottish Courts and Tribunals Service.
- The Scottish Ministers (covering, in effect, the Crown Office and Procurator Fiscal Service, and the Scottish Prison Service).
- 4.2. These statutory partners, along with a wide range of third sector and other relevant organisations, including those representing victims, have been represented on the Orkney Community Justice Partnership, developing the attached Plan.
- 4.3. The Scottish Government has provided guidance on the preparation of these local Community Justice Outcomes Improvement Plans in its "Community Justice Outcomes, Performance and Improvement Framework", published in 2016.
- 4.4. The New Model for Community Justice in Scotland involves the creation of Community Justice Partnerships in each of the 32 Local Authority areas, complemented by the new national body "Community Justice Scotland", which was due to commence its work in September 2016. Community Justice Scotland provided commentary. The attached Orkney Community Justice Outcomes Improvement Plan for 2018-21 was considered and endorsed by the Orkney Community Justice Partnership at its meeting on 27 February 2018.
- 4.5. During 2016-17 an Orkney Community Justice Needs Assessment exercise was undertaken, providing the most comprehensive and well-evidenced local account of Orkney's needs and resources in relation to Community Justice ever undertaken. In December 2017, the Orkney Community Justice Needs Assessment was updated, and provided with new data on matters such as local use of Bail Supervision and Support, feedback from people who had completed Community Payback Orders, and the age range of recipients of Community Justice services in Orkney. Many of the findings of this Needs Assessment were reassuring, echoing the findings of a number of national "Quality of Life" surveys, and including:
- Consistently low crime rates.
- Reconviction rates that have fallen over time, and are among the lowest in Scotland.
- Sustained exceptionally low levels of Youth Offending.
- Lower than average levels of drug misuse, subject to close monitoring.
- Consistently high successful completion rates for Community Payback Orders imposed by the Courts compared with other Local Authority areas.
- Very high levels of community perceptions of safety e.g. when walking alone.

4.6. In part, these positive indications flow from a lengthy history of positive local collaboration and co-operation in the field of Community Justice. There are, however, inherent challenges such as limitations of geographical isolation, small teams and highly variable demand in Orkney's specific context, as well as new developments and threats such as rapid changes in patterns of substance misuse, and internet-based offending.

Explicit links have been put in place between community planning, in the form of the Orkney Partnership Board, and the Orkney Community Justice Partnership, which encompasses partners at national level such as the Scottish Prison Service, and the Scottish Courts and Tribunals Service, that are outwith the scope of local community planning processes. The Orkney Community Plan 2016-19, which includes the Local Outcomes Improvement Plan (LOIP), formally acknowledges this linkage as follows:

During 2016-19, the Orkney Partnership Board will formally welcome the member representing Orkney's statutory Community Justice Partnership, formed in response to the Community Justice (Scotland) Act 2016 with a mission to bring together all the agencies involved in the planning, delivery and monitoring of community justice services in order to improve outcomes for service users and the wider community.

# 11. Risk and Equality assessment

- 11.1. The attached Equality Impact Assessment indicates that impacts will be positive. However, the Community Justice Partnership will be reviewing progress, so any unforeseen negative impacts will be identified.
- 11.2. The production and implementation of the Orkney Community Justice Outcomes Improvement Plan aims to address risk to the community by preventing and reducing further offending by addressing its underlying causes; and safely and effectively managing and supporting those who have committed offences to help them reintegrate into the community and realise their potential for the benefit of all citizens.
