Introduction by the Area Commander

Chief Inspector Scott Robertson

I present to you the Orkney Police and Fire Sub-Committee Scrutiny Report, covering the reporting period 01 April 2024 to 30 September 2024. I hope the style of the report is continuing to provide you with the required breakdown of crime statistics for Orkney Area Command.

The Orkney islands, characterised by its rural landscape and dispersed population, presents unique challenges for policing. Despite these challenges, your local policing team has worked diligently to maintain public safety, reduce crime, and increase community engagement.

This report provides you with a picture of the demand and activity which has been ongoing in Orkney over the last fiscal year. Despite a small increase in overall crime, detection rates have remained steady. The team has achieved an 86.3% detection rate for all crimes, demonstrating their commitment to solving crimes and bringing offenders to justice.

One of the main focuses for this time period has been Road Safety. Road crime numbers have generally increased, which can be attributed to proactive policing initiatives. We maintain a strong presence on the roads, collaborating with partners through initiatives like Operation CEDAR to promote safe driving practices via both education and enforcement to reduce serious traffic incidents. There have been no RTC Fatalities on our roads during this time period.

While Orkney has seen positive outcomes, challenges remain, including Rural Crime and anti-social behaviour. Isolated incidents of anti-social behaviour continue to be a concern to our communities. To address these challenges, future priorities will include taking a robust approach to anti-social behaviour, including working with partners to address underlying issues and Strengthening relationships with the community and responding to their concerns.

A significant focus during this period has been on tackling drug-related offences. Proactive operations and increased intelligence-led policing have led to a 7.7% increase in the detection of Supply of drug offences. This proactive approach has disrupted drug supply chains and reduced drug-related harm within the community.

Building strong relationships with the community is essential for effective policing. The team has actively engaged with local residents, businesses, and community groups through various initiatives. Strong partnerships have been forged with other agencies and voluntary organisations. These relationships assist in tackling local issues and improve community safety.

The report outlines an increase on the previous year in relation to Hate Crime related offences. There has been a national increase in Hate Crime related offences following the introduction of the Hate Crime and Public Order Act in April 2024. We continue to support victims of crime to engage with us and feel confident in reporting crimes to us.

The Orkney Islands continue to be a safe and resilient place for residents and visitors alike. The team's dedication to proactive policing, community engagement, and partnership working has been instrumental in achieving these results. By addressing emerging challenges and maintaining a focus on public safety, the team will continue to make a positive impact on the community.

Local Policing Priorities

The Local Policing Priorities for the N Division area are decided by data from our Strategic Assessment which details Threats and Risks, and also feedback from Local Authorities, Partners and residents in the Your Police survey.

Orkney: At a glance

Road Safety and Road Crime

Overall, Road Crime offences have increased by 39.1% (90 more offences) against the 5 Year Average and increased by 20.8% (55 more offences) against the Last Year To Date (LYTD).

Offences in relation to Unlawful use of motor vehicles have increased by 41.7% (26.8 more offences) against the 5 Year Average and increased by 56.9% (33 more offence) against the LYTD.

Mobile Telephone offences have increased by 350.0% (13.7 more offences) against the 5 Year Average and increased by 200.0% (12 more offences) offences against the LYTD.

Anti-Social Behaviour, Disorder and Violence (including Alcohol and Drugs Misuse)

Offences in relation to Breach of the Peace have decreased by 78.3% (3.6 fewer crimes) against the 5 Year Average and has stayed the same against the LYTD.

Offences in relation to Assault have decreased by 4.8% (2.2 fewer crimes) against the 5 Year Average and increased by 15.8% (6 more crimes) against the LYTD.

Acquisitive Crime

Offences in relation to Housebreaking (Dwelling House) have increased by 150.0% (1.2 more crimes) against the 5 Year Average and have increased by 100.0% (1 more crime) against the LYTD.

Fraud offences have increased by 1.9% (0.2 more crimes) against the 5 Year Average and decreased by 21.4% (3 fewer crimes) against the LYTD.

Protecting Vulnerable People

Overall, Sexual Crime has decreased by 23.8% (7.2 fewer crimes) against the 5 Year Average and decreased by 14.8% (4.0 fewer crimes) against the LYTD.

Domestic related offences have decreased by 38.5% (13.8 fewer crimes) against the 5 Year Average and decreased by 48.8% (21 fewer crimes) against the LYTD.

Offences in relation to Hate Crime have increased by 455.6% (8.2 more crimes) against the 5 Year Average and increased by 10 more offences against the LYTD.

Serious and Organised Crime

Offences in relation to Supply of drugs have increased by 288.9% (5.2 more crimes) against the 5 Year Average and increased by 600% (6 more crimes) against the LYTD.

Counter Terrorism & Domestic Extremism

Police Constable Lisa Campbell, N Division's Local Counter Terrorism Officer stated:

Road Safety and Road Crime


Intention - With Partners, enhance Road Safety across Orkney.

<u>Operation CEDAR</u> - (Challenge, Educate, Detect and Reduce) builds on established practices and will continue to focus on various agencies working in partnership to reduce the number of people killed and seriously injured in Orkney.

Operation CEDAR involves proactive multi-agency enforcement operations on the roads, which sits alongside education activity aimed at improving driver behaviour of all ages. Partner agencies continue to work together to improve understanding of the factors which could contribute to improving road safety for everyone on the roads and together respond to these issues.


Anti-Social Behaviour, Disorder and Violence (including Alcohol and Drug misuse)

Intention – With Partners, better understand the causes to prevent and reduce instances of Anti-Social Behaviour, Disorder and Violence to enhance community safety across Orkney.

Objective – Work with Partners to share information, support Education, Prevention, Diversionary and Enforcement Measures linked to harmful alcohol consumption; maintain robust procedures around licensed premises; support victims of violent crime by working with partners to improve service provision and prevent repeat victimisation.

Stop and Search -



Positive Stop Search - A positive stop and search is when an item is recovered where possession of same implies criminality on the part of the individual being searched or any other; or potentially compromises the safety of that individual or another.

No Knives, Better Lives - No Knives, Better Lives (NKBL) is a national capacity-building programme that supports primary prevention work related to knife carrying in Scotland. In 2009, the NKBL National Delivery Team at YouthLink Scotland and the Scottish Government began supporting partners in 11 selected Local Authority areas to implement NKBL. The approach to prevention is informed by the principles and values of youth work and a public health approach to violence prevention. The focus is not just on what it is we do not want young people to do and how to stop them doing it, but also what we want young people to be able to do, how we support them to understand and navigate risk and to make positive life choices.

Acquisitive Crime

Intention – With Partners and Communities, prevent instances of acquisitive crime across Orkney.

Objective – With Partners, share information, support education, prevention, diversionary and enforcement activity linked to acquisitive crime; develop work with targets – recidivist offenders to reduce reoffending linked to acquisitive crime e.g. Persistent Offenders programme; enhance the use of all media platforms to raise awareness of local and national preventative initiatives.

Protecting Vulnerable People


Intention - Protect people at risk of harm.

Objective – With Partners we will focus on safeguarding communities; with Partners we will address emerging issues through Prevention and Intervention.




Domestic Crime – N Division continues to work with Partner Agencies in order to support victims of such crimes.

Hate Crime -

Hate Crime incidents are reviewed on a daily basis by officers within N Division's Partnerships Department with the victim being contacted and provided with contact details for Partner Agencies such as Victim Support Scotland. Every victim of a Hate Crime continue to be sent a Satisfaction Survey as to how they felt they were supported by N Division.

Missing Persons -

Police Scotland takes every report of a missing person seriously and investigates appropriately with access to local, regional and national specialist resources. Missing persons investigations are a core part of local Policing and it is local officers who undertake all investigations, supported by specialist colleagues where necessary. Further, each Division including, N Division has a dedicated Missing Person Co-ordinator who advises on operational and preventative approaches.

Each Area Command has appointed a local Police liaison officer who maintains contact and liaison with the residential units in their respective area. This role has developed and regular contact has built a good relationship with residential unit(s). Where required, this officer also works in conjunction with the Missing Person Co-ordinator who similarly enjoys a good working relationship with residential units.

Serious and Organised Crime

Intention – With Partners, reduce the threat, risk and harm caused by Serious Organised Crime.

Objective – With Partners work to safeguard the Orkney area by taking all opportunities to prevent crime and make the Orkney area a hostile environment for Serious & Organised Crime Groups; to improve outcomes for individuals and communities and reduce offending through prevention, early intervention and diversion; in support of our Partners in the Local Authority and NHS via the Alcohol and Drug Partnership Strategy we will direct those who are substance dependant towards recovery through prevention, treatment and support services; with Partners work to reduce the instances of substance misuse in our communities.

Counter Terrorism

Intention – Support the delivery of the CONTEST strategy to reduce the threat posed by terrorism and domestic extremism.

Objective – Strengthen PREVENT work with Partners and institutions; with Partners, support individuals who are vulnerable to terrorism and violent extremism; strengthen PREVENT work in relation to the internet and Social Media; Effective Multi-agency planning in respect of Counter Terrorism is taking place; Develop our ability to response effectively to any terrorist attack (with a specific focus on emerging high-risk threats, and specialist capabilities).

WRAP (Workshop to Raise Awareness of Prevent) - The workshop covers issues such as crime, normal social processes that are used to influence and manipulate, case studies that cut across the spectrum of extremism, terrorist ideologies and factors which may contribute to an individual's susceptibility to a terrorist ideology.

In particular, it seeks to support them to recognise that using their existing expertise and professional judgement, they may be able to recognise potentially vulnerable individuals who may be susceptible to being persuaded by an extremist or terrorist ideology. Workshops delivered to partners across Orkney.

ACT Now delivered to schools across Orkney.

Training is available on various CT subjects including radicalisation awareness and ACT Awareness".
