## **1. Appointment of Convener**

The Senior Committees Officer, Orkney Islands Council, welcomed everyone to the meeting, and asked for nominations for Convener.

## 2. Minute of Previous Meeting

There had been previously circulated the draft Minute of the Meeting of the Licensing Forum held on 6 November 2019.

On the motion of Andy McGinn, seconded by Barry Cockerham, the Forum resolved to approve the Minute of the Meeting of the Licensing Forum held on 6 November 2019.

## 3. Matters Arising

There were no matters arising from the Minute of the previous Meeting held on 6 November 2019.

## 4. Orkney Street Pastors

Barry Cockerham gave a short update on the safe space at Kirkwall Travel Centre which operated on "Mad Friday", 20 December 2019, and advised that the Street Pastors had previously agreed with PC Simon Hay that they would remain out on patrol and direct people to the safe space, rather than be based within the safe space.

PC Simon Hay advised that the event had been a success and showed great partnership working, with plans to do a similar event in 2020.

Barry Cockerham suggested that consideration be given to a similar arrangement for County Show night, which was another date in the Orkney calendar when large numbers of people were out socialising. However, with the amount of effort required to co-ordinate the "Mad Friday" event, he suggested it should be considered on an event by event basis, rather than being a regular weekly or monthly event.

Andy McGinn suggested that Stromness Shopping Week was another potential event, however Barry Cockerham advised that the Street Pastors had patrolled during the Saturday night and Stromness Shopping Week was now more family orientated, rather than large concentrations at or near pubs, and they did not see a need for such a facility, nor for the Street Pastors to be visible in Stromness during that time.

PC Simon Hay agreed with Barry Cockerham and advised of the logistics of setting up the Mad Friday safe space, which required eight main partners, although all the comments received had been very positive.

## 5. Pubwatch

PC Simon Hay gave a brief update on the continuing development of Orkney Pubwatch, with the new system working well. Over the Festive period, there had been requests for bans and warnings. Funding applications had been submitted in respect of insurance cover and registration with the Information Commissioner. No new members had joined Pubwatch since the last update.

Andy McGinn queried what progress had been made since the joint meeting in November 2019 on the proposal that membership of Pubwatch become a mandatory condition on licences. Duncan Tullock advised that a report would be considered by the Board in due course and he would keep the Licensing Forum advised accordingly.

Gillian Morrison joined the meeting at this point.

## 6. Licensing Standards Officer

As David Brown was not present, no update on the work of the Licensing Standards Officer was given.

## 7. Any Other Competent Business

PC Simon Hay gave a quick update on crime statistics over the festive period and advised that 12 officers were out on patrol on Mad Friday. Of particular note were, although there were three cases of assault and three minor disorder, there were no serious assaults. However, all the assaults were alcohol-related.

## 8. Dates for Future Meetings

It was agreed that the next meeting of the Licensing Forum should be held on Thursday, 26 March 2020 at 10:00.
