Local Review Body: 3 April 2025.

**Proposed Conversion of Meeting Room to Two Self-catering Units,
Install Replacement Windows and Doors and Two Air Source Heat
Pumps with Housing (Resubmission of 23/313/PP) at 10 Bridge Street
Wynd, Kirkwall (23/465/PP).**

Report by Chief Executive.

1. Overview

- 1.1. Planning application 23/465/PP in respect of the proposed conversion of a meeting room to two self-catering units and installation of replacement windows and doors and two air source heat pumps with housing (resubmission of 23/313/PP) at 10 Bridge Street Wynd, Kirkwall, was refused by the Appointed Officer on 22 August 2024.
- 1.2. Under the Town and Country Planning (Scotland) Act 1997 (the Act) and the Town and Country Planning (Schemes of Delegation and Local Review Procedure) (Scotland) Regulations 2013 (the Regulations), where an application for planning permission for local development has been determined by the Appointed Officer in accordance with the Council's Planning Scheme of Delegation, the applicant is entitled to seek a review of that decision by the Local Review Body.
- 1.3. The applicant has submitted a Notice of Review (see Appendix 1) requesting that the decision of the Appointed Officer, referred to at paragraph 1.1 above, be reviewed. The applicant has indicated that the review can be determined without any further procedures.
- 1.4. The matter was first considered by the Local Review Body on 13 December 2024, when the Committee determined it did not have sufficient information in order to proceed to determine the review and accordingly, resolved that the Review should not be determined without further procedure.
- 1.5. The Local Review Body determined that the further procedure should comprise further information by means of written submissions, as set out in Regulation 15 of

the Regulations, from the applicant, with the undernoted parties named on the Procedure Notice, so that they might comment on the information provided by the applicant:

- Orkney Islands Council's Engineering Services (Engineering Services)
- Scottish Environment Protection Agency (SEPA).

- 1.6. The Local Review Body resolved that the further information should comprise clarification from the applicant as to the difference in height between the pavement level and internal floor level given the changes made to the Flood Risk Assessment submitted as part of the notice of review.
- 1.7. A Procedure Notice was issued to the applicant's agent on 28 January 2025 with a request that the further information be provided no later than 10 February 2025.
- 1.8. On 4 March 2025, the Local Review Body was advised that a Procedure Notice Response had not been received from the applicant's agent by 10 February 2025. However, a Procedure Notice Response was received from the applicant's agent on 3 March 2025, with the agent stating that the deadline of 10 February 2025 had been missed as the Procedure Notice had been issued when they were on holiday.
- 1.9. The Local Review Body subsequently resolved:
 - That, as the response from the applicant's agent included information which was important to determining this Review, the late Procedure Notice Response, referred to at paragraph 1.8 above, should be allowed into process.
 - That, accordingly, the parties identified [in paragraph 1.5 above], namely Orkney Islands Council's Engineering Services and SEPA, should be afforded two weeks from 4 March 2025 to submit comments in response to the Procedure Notice Response.
- 1.10. Orkney Islands Council's Engineering Services and SEPA have both responded to the Procedure Notice Response.
- 1.11. A letter from the Chief Planner, Scottish Government, issued in July 2011, confirmed that a review by a Local Review Body should be conducted by means of a full consideration of the application afresh.
- 1.12. Section 21 of the Scheme of Administration states that the Local Review Body will undertake unaccompanied site inspections for all planning applications subject to a review, prior to meeting to consider the review. The purpose of the site inspection, together with the procedure to be adopted, are set out in section 21.2

of the Scheme of Administration. An unaccompanied site inspection to 10 Bridge Street Wynd, Kirkwall, took place on 11 December 2024 at approximately 14:45.

- 1.13. As SEPA, being a Government Agency, has objected to application 23/465/PP on the grounds of flood risk, in accordance with the Town and Country Planning (Notification of Applications) (Scotland) Direction 2009, if the Local Review Body is minded to reverse the decision of the Appointed Officer then the Local Review Body must notify the Scottish Ministers. The Local Review Body must not grant planning permission before the expiry of a period of 28 days beginning with the day of notification. Further details are provided in section 6 below.
- 1.14. The review procedure is set out in section 4 below.

2. Recommendations

- 2.1. The Local Review Body is required to:
 - i. Determine whether it has sufficient information to proceed to determination of the review, and if so whether to uphold, vary or be minded to reverse the decision of the Appointed Officer.
- 2.2. Should the Local Review Body determine that the decision is varied or be minded to reverse the decision, it is required to:
 - i. Determine the reasons, and, if applicable, the relevant matters in respect of potential conditions to be attached to the decision notice.
- 2.3. Should the Local Review Body be minded to reverse the decision, the Local Review Body should notify the Scottish Ministers of its intention to approve planning permission, subject to conditions.
- 2.4. Should the review not be called in by Scottish Ministers for determination, it is recommended that members of the Local Review Body:
 - i. Delegate powers to the Chief Executive, following consultation with the Planning Advisor and the Legal Advisor, to determine the necessary conditions and informatives to attach to the Decision Notice.

- 2.5. Should the Local Review Body determine that it does not have sufficient information to proceed to determination of the review, it is required to:
- i. Determine what further information is required, which parties are to be requested to provide the information, and whether to obtain further information by one or more of the following methods:
 - By means of written submissions under the procedure set out in Regulation 15 of the Town and Country Planning (Schemes of Delegation and Local Review Procedure) (Scotland) Regulations 2013; and/or
 - By the holding of one or more hearing under the Hearing Session Rules set out in Schedule 1 of the Town and Country Planning (Schemes of Delegation and Local Review Procedure) (Scotland) Regulations 2013.

3. Planning Authority Decision

- 3.1. The Planning Handling Report, Planning Services file and the Decision Notice are attached as Appendices 2, 3 and 4 to this report.
- 3.2. On 22 August 2024, the Appointed Officer refused planning application 23/465/PP on the following grounds:
- The proposal does not comply with National Planning Framework 4 Policy 22 – Flood risk and water management as it may increase the risk of surface water flooding to others, or itself be at risk.
 - The proposal does not comply with Orkney Local Development Plan 2017 Policy 13 – Flood Risk, SuDS & Waste Water Drainage as would result in a situation where development would have a significant probability of being affected by flooding.

4. Local Review Procedure

- 4.1. In response to a Notice of Review, “interested parties” are permitted to make a representation to the Local Review Body. “Interested parties” include any party who has made, and not withdrawn, a representation in connection with the application. A representation was received from Orkney Heritage Society and is attached as Appendix 5.
- 4.2. In instances where a representation is received from an “interested party”, the applicant is afforded the opportunity to make comments on any representation received. No further comment was received from the applicant or the agent.

- 4.3. As outlined in section 1 above, on 13 December 2024, the Local Review Body resolved that it had insufficient information to determine the review and agreed that the further procedure should comprise further information by means of written submissions, as set out in Regulation 15 of the Town and Country Planning (Schemes of Delegation and Local Review Procedure) (Scotland) Regulations 2013.
- 4.4. On 28 January 2025, a Procedure Notice was issued to the applicant's agent, attached as Appendix 6. The applicant's agent was also advised that, in accordance with the Regulations, as well as submitting their Procedure Notice Response to the Local Review Body, they must send a copy to SEPA and Engineering Services. This was to be done no later than 10 February 2025.
- 4.5. As outlined in section 1 above, on 4 March 2025, the Local Review Body was advised that a Procedure Notice Response was received from the applicant's agent on 3 March 2025, with the agent stating that the deadline of 10 February 2025 had been missed as the Procedure Notice had been issued when they were on holiday. The Procedure Notice Response is attached as Appendix 7 to this report.
- 4.6. The Local Review Body agreed that the late Procedure Notice Response should be allowed into process and that Orkney Islands Council's Engineering Services and SEPA, should be afforded two weeks from 4 March 2025 to submit comments in response to the Procedure Notice Response.
- 4.7. The response from SEPA is attached as Appendix 8.
- 4.8. The response from Engineering Services is attached as Appendix 9.
- 4.9. The Local Review Body may uphold, vary or be minded to reverse the decision of the Appointed Officer. In the event that the Local Review Body is minded to reverse the decision, an indication of relevant matters, in respect of potential planning conditions, are as follows:
 - Duration of consent.
 - Occupation as self-catering accommodation.
 - Air source heat pump noise.
 - Air source heat pump housing.
 - Replacement window and door specification.
 - Replacement window and door implementation.
- 4.10. All conditions should be in accordance with Planning Circular 4/1998 regarding the use of conditions in planning permissions.

- 4.11. If the Local Review Body is minded to reverse the decision of the Appointed Officer, and the Scottish Ministers do not call in the review for determination following the notification procedure set out in section 6, it is proposed that powers are delegated to the Chief Executive, following consultation with the Planning Advisor and the Legal Advisor, to determine the necessary conditions and informatives, based on the relevant matters, agreed in terms of section 4.9 above.
- 4.12. If the Local Review Body is minded to reverse the decision of the Appointed Officer, then planning permission must not be granted until the notification procedure set out in section 6 has been undertaken.
- 4.13. If the Local Review Body decides that further procedure is required, it may decide to hold a pre-examination meeting to consider what procedures to follow in the review, or to obtain further information by one or more of the following methods:
- By means of written submissions under the procedure set out in Regulation 15 of the Town and Country Planning (Schemes of Delegation and Local Review Procedure) (Scotland) Regulations 2013; and/or.
 - By the holding of one or more hearing under the Hearing Session Rules set out in Schedule 1 of the Town and Country Planning (Schemes of Delegation and Local Review Procedure) (Scotland) Regulations 2013.

5. Relevant Planning Policy and Guidance

- 5.1. Section 25 of the Act as amended states, “Where, in making any determination under the Planning Acts, regard is to be had to the development plan, the determination is, unless material considerations indicate otherwise ... to be made in accordance with that plan...”
- 5.2. The full text of the Orkney Local Development Plan 2017 (OLDP 2017) and other supplementary planning advice and guidance can be read on the Council website [here](#). Although the Orkney Local Development Plan is “out-of-date” and has been since April 2022, it is still a significant material consideration when considering planning applications. The primacy of the plan should be maintained until a new plan is adopted. However, the weight to be attached to the Plan will be diminished where policies within the plan are subsequently superseded.
- 5.3. National Planning Framework 4 was approved by Parliament on 11 January 2023 and formally adopted by Scottish Ministers on 13 February 2023. The statutory development plan for Orkney consists of the National Planning Framework and the Orkney Local Development Plan 2017 and its supplementary guidance. In the event of any incompatibility between a provision of National Planning Framework 4 and

a provision of the Orkney Local Development Plan 2017, National Planning Framework 4 is to prevail as it was adopted later. It is important to note that National Planning Framework 4 must be read and applied as a whole, and that the intent of each of the 33 policies is set out in National Planning Framework 4 and can be used to guide decision-making.

5.4. It is for the Local Review Body to determine which policies are relevant to this application; however the policies listed below were referred to by the Appointed Officer in the Planning Handling Report:

- Orkney Local Development Plan 2017:
 - Policy 1 – Criteria for All Development.
 - Policy 3 – Settlements, Town Centres and Primary Retail Frontages.
 - Policy 8 – Historic Environment and Cultural Heritage.
 - Policy 13 – Flood Risk, SuDS and Waste Water Drainage.
- National Planning Framework 4:
 - Policy 7 – Historic assets and places.
 - Policy 22 – Flood risk and water management.
 - Policy 27 – City, town, local and commercial centres.
 - Policy 30 – Tourism.

6. Notification Requirements

6.1. The development is subject to objection by a Government Agency, in this case an objection by SEPA in relation to flood risk.

6.2. Under the provisions of the Town and Country Planning (Notification of Applications) (Scotland) Direction 2009, should a planning authority, in this case the Local Review Body, propose to approve planning permission for a development falling within any of the descriptions of development listed in the Schedule to the above Direction (including where the application has been subject to objection from SEPA on grounds of flooding), the planning authority shall notify Scottish Ministers.

6.3. A planning authority must not approve planning permission for development before the expiry of a period of 28 days, beginning with the date of receipt by the Scottish Ministers of information which the planning authority is required to provide.

Orkney Heritage Society is disappointed that this application was refused due to the potential of flooding and consider the stance taken by SEPA and the planners to be over cautious. It also has worrying implications. Does this decision preclude any ground floor habitation in this area? To keep our town centres vibrant, its buildings need to be used and maintained. Converting this property to self catering units is a good use of this existing property.

The scale of flood risk being considered is only 300mm or so deep. Whilst this is damaging, the location of the site is not one of great risk such as on the edge of a harbour or where there is a risk of washed-in debris of any substance. The risk to the life of residents will be low if the area is flooded, further reduced by the fact that the property will be supervised by the applicants, who have access to any weather warnings. With Orkney's short watercourses any fluvial flooding is likely to be short-lived. Tidal flooding may be of longer duration, but that too is likely to be only hours in duration. The need to evacuate people in that period is therefore smaller than where a site could be cut off for days as floodwaters from up-catchment come through the site. Overall the risk seems small, short and manageable.

In terms of further reducing flood risk:

1. Ensure the heat pumps are sited above flood level to prevent damage.
2. There is reference to plasterboard finishes. It would be reasonable to only start these finishes above flood level and to hard plaster with resistant plaster below flood level, so ensuring no damage to wall finishes.
3. There is reference to electrical equipment being above flood level. This can be achieved by ensuring that all cables drop from the ceiling to high level outlets rather than coming up from under the floor.
4. The use of flood proof surfaces such as polished concrete floors with rugs, tiles or with vinyl rather than timber would be a sensible.

Under the terms of the attached correspondence from Orkney Islands Council we would confirm that the finished floor level will be 300mm above the adjacent pavement level per the revised document which corrected a typo in the original.

Further we would note with regards to Flood risk we would respond as follows:

The historic flooding of 2006 was caused by the entrance to the Willow burn culvert becoming blocked with debris leading to the water over topping the culvert and flowing down Bridge Street Wynd not by the culvert reaching capacity and the water then over topping the culvert entrance. Since then new barriers have been installed further up from the entrance to the culvert (at Well Park Garden Centre) to catch debris and prevent it from blocking the actual entrance to the culvert. The culvert cannot have been classed as at near capacity as in 2018 we were allowed to put a 150mm sewer through the culvert to connect the foul drain from The Storehouse Restaurant with Rooms to the existing foul sewer on the other side of the culvert.

With the works that have been carried to to prevent the entrance being blocked and fact that the culvert is not at capacity flooding should not now happen again.

There are no grounds to refuse this application with regards to flood risk which was the only grounds for refusal.

Planning Consent should be granted to allow the ground floor (and upper floor included in the application) of this building to be redeveloped to provide additional bed spaces for The Storehouse Restaurant with Rooms, with the ever growing need for additional accommodation in Kirkwall and in Orkney as a whole.

Thank you for your email and letter regarding the above application which was received by SEPA on 4 March 2025. We previously responded to this application in our letter referenced PCS-20001265 (13 June 2024). We have reviewed the information submitted by the applicant in response to the Procedure Notice under Regulation 15 and the information submitted by the applicant in their Notice of Review. However, unfortunately the submitted information does not change our position and we continue to **object in principle** to the application on the grounds of flood risk. Please see our previous response (PCS-20001265) and, in addition, we wish to comment as follows:

- 1.1 We note that the applicant has outlined that previous flooding at the site has been due to blockage of the upstream culvert, that the culvert has capacity for flood flows, and that steps have been taken which will prevent blockage, and subsequent flooding, occurring in the future.

- 1.2 Whilst we accept that flooding in 2006 may have been caused, or exacerbated by, blockage to the upstream culvert, modelling undertaken by Scottish Water indicates that surcharging of the network will occur during a 1 in 200 year including climate change event even with no blockage. We also accept that the risk of blockage is likely to be reduced by the works undertaken, however, it cannot be eliminated entirely. Flooding in this area may therefore occur due to an exceedance of the capacity of watercourse/culvert, and this may be exacerbated by blockage.
- 1.3 In addition to the comments on flood hazard, we understand that there has been clarification provided on the internal Finished Floor Levels and these are to be marginally raised above existing, to be 0.3m above pavement level, and not the 0.55m above pavement level we had previously understood and responded based on. This level is expected to be approximately similar to the flood level and so no freeboard provision will be available for any uncertainties in the modelling or where water levels can be increased e.g. by waves caused by vehicles.
- 1.4 We note that emergency access/egress is to be provided to the rear of the building via bathroom windows. NPF4 defines safe, flood free pedestrian access and egress as being a route for the movement of people of all abilities, which this does not appear to comply with.

Engineering has reviewed the information related to flood risk submitted since our last consultation response as follows:

- **Leslie Burgher Chartered Architect:**
Flood Risk Assessment - Revision B – September 2024
Statement of Grounds for Review
Email From Agent in Response to Regulation 15 – 3rd March 2015

The Flood Risk Assessment document provided by the Agent in April 2024 was presented in the form of a report addressing the six property flood resilience Standards described in Ciria C790, the Code of Practice for Property Flood Resilience. It was understood from the April 2024 Flood Risk Assessment that there would be 550mm from footway level to finished floor level. This allowed modest freeboard above predicted flood level. Together with the information addressing the remaining five PFR Standards, including the information regarding the operation of this commercial building, we considered the assessment of flood risk to be acceptable and did not object to the application in May 2024.

The September 2024 revision of the Flood Risk Assessment provided for the application indicates that there would be no freeboard above the modelled height of flood water and the 3rd March email from the agent advises that the 300mm above existing floor level from the April 2024 Flood Risk Assessment was a typo. We therefore consider that the Flood Risk Assessment document provided does not satisfactorily address the six PFR Standards from Ciria C790 and object to the application.
