1. Purpose of Report

To consider making a nomination to a vacancy on the Board of Directors of Orkney Ferries Limited.

3. Background

3.1.

Following the death of Councillor Kevin F Woodbridge, a vacancy exists on the Board of Directors of Orkney Ferries Limited.

3.2.

In terms of the Section 2.1.18 of the Scheme of Administration, appointment of Members of the Council to external bodies is a retained function of the Council. Nomination of a Member to the Board of Orkney Ferries Limited therefore falls within the remit of the Council. In terms of the constitutional arrangements, appointments to the Board of Orkney Ferries Limited last for the term of office.

3.3.

Council nominations are considered by the Board of Directors who ultimately make the appointment.
