1. Apologies

Resolved to note that apologies for absence had been received from C Fraser.

2. Adoption of Minutes

3. Matters Arising

Members heard that amendments had been made to the Community Emergency Plan and that this was now ready for forwarding to emergency service providers. It was also reported that a new battery would be purchased for the stand-by generator, and it was:

C. Loganair

5. Plastic Recycling Skip Trial

6. Stronsay Slaughterhouse Report

7. Stronsay Fish Mart Report

Members heard that replacement skylights had been fitted to the Fish Mart roof and that repairs had been completed on reported faults. Consideration was also given to the disposal of the hostel mattresses, once the new ones had been received, a faulty microwave oven, a pay as you use shower in the public shower room and a thermal imaging camera survey and energy efficiency advice, and it was resolved:

A. That on receipt of the new hostel mattresses the old ones would be advertised as being free for collection.

B. That the Clerk would enquire into fitting a pay as you go shower meter in the public shower room.

C. That S Weaver would continue to liaise with Resource Efficient Scotland regarding energy efficiency advice.

B. That the winter Inter-Island Air Services timetable 27 October 2019 – 1 March 2020 be changed to allow Stronsay passengers a longer stay in Kirkwall on a Saturday during the ferry refit timetable.
