Licensing Committee: 13 March 2025.

Review of Licensing Fees.

Joint Report by Corporate Director for Strategy, Performance and Business Solutions and Corporate Director for Neighbourhood Services and Infrastructure.

1. Overview

- 1.1. The Council functions as a licensing authority are funded directly by income raised from licence application fees.
- 1.2. In some cases, the Council has discretion to set fees, generally on the basis that fees charged should cover its expenses in the processing of applications. In other cases, fees are prescribed by statutory instrument or regulations.
- 1.3. The minimum annual increase to these fees is normally approved by the Council as part of the annual budget process. Licensing fees are an exception to that process.
- 1.4. Advertisement costs and third-party costs with related administration are met directly by applicants and licence holders.

2. Recommendations

- 2.1. It is recommended that members of the Committee:
 - i. Agree that, where the Council has discretion, with effect from 1 April 2025, licensing fees be increased by a minimum of 10%, resulting in the fee levels detailed in Appendix 2 to this report.

3. Background

3.1. On 21 March 2024, the Licensing Committee determined that, where the Council had discretion, with effect from 1 April 2024, licensing fees be increased by a minimum of 6.7%.



3.2. The Licensing budget for 2024/25 of £17,400 is made up as follows:

- 3.3. The fees and charges collected are principally:
 - Short-term Let Licensing (STL) (40%).
 - Liquor Licensing fees (31%).
 - Licences, Approvals, Registrations and Permits fees (29%) which are the subject of this report.
- 3.4. Environmental Health and Trading Standards income in respect of licensing fees, subject to the categories determined by the Licensing Committee, for 2023/24 was £408 for licences administered by Environmental Health and £692 for licences administered by Trading Standards. Estimated income for 2024/25 is £912 for licences administered by Environmental Health and £865 for licences administered by Trading Standards.

4. Proposed Charges

- 4.1. A comparison of fees charged by the Council with fees charged for similar types of licences or approvals by other local authorities in the north of Scotland has been conducted, with the outcome detailed in Appendix 1 to this report.
- 4.2. The comparison information relates to financial year 2024/25. The local authorities concerned have not completed their review processes for financial year 2025/26.
- 4.3. On 4 March 2025, when considering the revenue budget for 2025/26, the Council resolved inter alia that Corporate Directors should increase existing charges by a minimum of 10%, from 1 April 2025, if possible to do so, or as early as possible thereafter, with exceptions, where alternative arrangements were required. One of the exceptions is licensing fees.
- 4.4. When calculating increases for the Council charges register, the following guidance has been issued in respect of rounding for ease of collection:
 - Less than £2.00 10% rounded up to nearest 10p.
 - £2.00 to £49.99 10% rounded up to nearest 10p.

- £50.00 to £99.99 10% rounded up to nearest 50p.
- £100.00 and over 10% rounded up to nearest £1.
- 4.5. Appendix 2 to this report lists those licences, registrations and permits issued by the Council, where it has discretion in the setting of fees. It sets out the present level of fees, together with the level of fees proposed to take effect from 1 April 2025, taking cognisance of the guidance referred to above.
