1. Apologies

Resolved to note that apologies for absence had been received from Ms A Kinsey and Councillor G Bevan.

A. Transport Forum/Community Survey Update

Following consideration of an update on the Transport Forum, along with the Community Survey Update, it was:

Resolved to note the following:

- The request for a change to the first morning ferry, from Monday to Friday, that the Hoyhead will call at Flotta and then to Lyness, would be implemented into the Summer 2025 timetable, and was agreed, in principle.
- The decision was made to keep Saturday sailings as they are at the moment.
- The ILO would distribute a public notification once the draft timetables have been agreed and published.

B. JMF Groat Invoices for Aggregate and Haulage

Following consideration of an update from the ILO to advise that the invoice for both the supply and haulage of aggregate by JMF Groat had been received and paid, it was:

Following consideration of concerns raised by Mrs I Mathieson regarding a recent visit by a Harbours official advising that 'anything but GCA items could be placed in the store' meaning that a local resident who stored their bike there for a couple of hours off island would no longer be acceptable and that parking could no longer take place on the pier, restricting accessibility for less abled residents to access the ferry, it was:

Resolved to note the contents of the concerns and that Councillor L Hall would address the issue directly with the official and provide feedback to the CC.

C. Graemsay Timetable

Following consideration of a request that the 18:00 sailing from Stromness to Graemsay and Moaness was made a permanent part of the timetable and no longer needed to be pre-booked, it was:

Resolved to note the request and that the ILO would raise the request with both Orkney Ferries and Orkney Harbours.

Following consideration of a concern raised that existing kirkyards on both Graemsay and Hoy were nearing capacity, it was:

Resolved to note the concern and for the ILO to request an update on previous OIC discussions to resolve the situation, on the Business Letter.

E. Verge cutting on Graemsay

Following consideration of a concern raised by a Graemsay resident that the verges on the island had not been cut this year, it was:

Resolved to note the concern and for the ILO to raise again on the business letter.

F. Degeneration of gabions on Graemsay

Following consideration of a concern raised that there was an issue with the gabions degenerating on the east side sea wall, it was:

Resolved to note the concern and for the ILO to raise the issue on the OIC portal.
