Review of Polling Districts and Polling Places.

Report by Corporate Director of Strategy, Performance and Business Solutions.

# 1. Overview

- 1.1. The Representation of the People Act 1983 places a duty on the local authority to review its UK Parliamentary polling districts and polling places regularly.
- 1.2. Compulsory reviews must be started and completed within the period of 16 months that starts on 1 October of every fifth year after 1 October 2013. The last review of Polling Districts and Polling Places for Orkney was completed in January 2020.
- 1.3. Our most recent compulsory review, which required to be started and completed between 1 October 2023 and 31 January 2025, ran for a period of one month from 15 November 2024, closing on 16 December 2024.
- 1.4. The aims of the review are as follows:
  - i. To ensure that all the electors in the constituency have such reasonable facilities for voting as are practicable in the circumstances.
  - ii. To ensure that, so far as is reasonable and practicable, the polling places are accessible to all electors, including those who are disabled.
- 1.5. In response to specific issues raised during election events prior to the compulsory review, the consultation proposed that changes be made to Kirkwall East and West, South Isles, Harray and Sandwick, Evie and Rendall, South Ronaldsay and Burray and North Isles Polling Places, as detailed in Annex 3 to this report.
- 1.6. Twenty-nine representations were received either direct from organisations or individuals or through our electronic survey, The feedback received from the current review concludes that the electorate are generally happy with the existing arrangements and facilities for voting. Full details of the comments received are contained within Annexes 1 and 2 to this report.

# 2. Recommendations

- 2.1. It is recommended that members of the Committee:
  - Note the comments received from the most recent compulsory review of polling districts and polling places, as set out in Annexes 1 and 2 respectively to this report.
  - ii. Agree the undernoted changes to polling places:
    - The Pickaquoy Centre should be the new Polling Place for the Kirkwall East and Kirkwall West, and North and South Isles electorate.
    - The Milestone Kirk in Dounby should be the new Polling Place for the Harray and Sandwick electorate.
    - The Rendall Community Centre should be the new Polling Place for the Evie and Rendall electorate.
    - The Cromarty Hall should be the new Polling Place for the South Ronaldsay and Burray electorate.

# 3. Consultation

- 3.1. A notice of the review was placed on the Council's website and a public notice was placed in the Council Offices advising of the review and inviting comments. A press release was passed to the local media for reporting in the local press and radio station. Social media was also used to promote the consultation throughout the consultation period. The questionnaire was available both electronically and in paper format so as to encourage a good response.
- 3.2. Consultation took place with the following:
  - i. The general public.
  - ii. Elected Members.
  - iii. The Member of Parliament.
  - iv. The Member of the Scottish Parliament.
  - v. Community Councils.
  - vi. Orkney Disability Forum.
  - vii. Voluntary Action Orkney.
  - viii. Returning Officer.
- 3.3. As part of routine Polling Station Inspection, mainland polling places were visited during the UK Parliamentary Election on 4 July 2024. The visits focused on electoral accessibility, particularly in relation to disabled access, both internally and externally, signage, parking location and facilities.

- 3.4. Observations from all Polling Place staff on Polling Day are also routinely sought following each election and any amendments included for the next electoral event.
- 3.5. In response to specific issues during previous election events prior to this review, the consultation proposed that changes be made to the following Polling Places:
  - i. The St Magnus Centre was the previous Polling Place for all Kirkwall East and Kirkwall West Polling Places, as well as for any electorate wishing to vote in person on polling day for the South and North Isles. However, since COVID and the social distancing arrangements that were required, it was necessary to relocate to The Pickaquoy Centre and it is proposed to make this move permanent as this venue has been well received, provides greater parking availability and greater space for the number of polling stations required.
  - ii. Harray Community Centre was the previous Polling Station for Harray and Sandwick however due to the hall being unavailable a temporary move was made to the Milestone Kirk in Dounby. As the Kirk is located within walking distance of the village of Dounby, it is proposed to make this move permanent.
  - iii. Evie Church was the previous Polling Place for Evie and Rendall electorate, however, due to the building being unavailable for the foreseeable future, the Polling Place was relocated to Rendall Community Centre and it is proposed to make this move permanent.
  - iv. St Margaret's Hope Primary School, Community Room, was the previous Polling Place for South Ronaldsay and Burray electorate, however due to the unavailability of the Community Room during the pandemic, the polling place was relocated to the Cromarty Hall and it is proposed to make this move permanent as it provides an easily accessible Polling Place with no disruption to the school.

# 4. Consultation Response

4.1. Representations to the Review were received with a full breakdown of these comments attached as Annex 1 to this report. A summary of the 29 responses received is as follows:

- 4.2. The consultation was undertaken following the most recent election event which was held in July 2024 and saw the implementation of a number of changes to the UK electoral system arising from the Elections Act 2022. In addition, some voters across Scotland experienced delays in receiving their postal vote packs due to national issues with printing and delivery. As a result, the Public Administration and Constitutional Affairs Committee in the UK Parliament has launched an inquiry into the general election which will include arrangements for supporting postal voting.
- 4.3. The issue with some delayed postal vote packs experienced in the most recent UK Parliamentary election was not specifically referred to in the consultation responses, however three representations were received from North Isles constituents requesting the reinstatement of Polling Stations in the Isles.
- 4.4. The removal of polling stations from the isles was fully considered and agreed at the Policy and Resources Committee in November 2011 following a public consultation. The drivers for change in November 2011 which led to the decision to remove the isles are still relevant today. These include costs, staffing, risk and practicalities of running polling stations across the ferry linked isles. The opt in for a postal vote of the electorate on the ferry linked isles rose to 75% of the electorate and turnout in the subsequent elections has been good better than the average turnout experienced in Scottish elections.
- 4.5. In terms of the accessibility for pedestrians, the change of venue for a polling station does result in it being further away from those who lived closer to the previous polling station venue and conversely closer to those who live beside the new venue. The new venues have each been identified to provide broader benefits in terms of wider accessibility inside the polling station and availability of venue within the specific polling district.

# 5. Conclusion

5.1. It is concluded that, following consideration of the responses to the compulsory review as set out in Annexes 1 and 2 respectively to this report, the changes detailed on the list of proposed polling places as set out in Annex 3 to this report are recommended for approval.

Islands can be identified as the collective Orkney Islands (of around 20 inhabited islands), as a group (ie North Isles, South Isles, ferry-linked isles) or individually (ie Westray, Sanday, Stronsay etc).  Islands will be considered in accordance with the Islands (Scotland)

What data is available about the current situation in the islands?	At present the outer island electors have 3 options for placing their vote:-
	They can apply for a postal vote; or
	They can appoint a proxy to vote on their behalf; or
	A polling station is always available on the Mainland for those that wish to cast their vote in person on Polling Day.
	The decision to introduce postal votes for the outer isles was taken in November 2011 following a public consultation and has worked well since this introduction with the majority (over 80%) of electorate applying for postal votes as well as some attending on the day of poll for casting their vote in person on the Mainland.
	The drivers for change included:-
	Higher turnout/return rate for postal votes compared with turnout for fixed polling stations;
	<b>Speed of Declaration</b> – postal packs returned are processed at the start of the Count as opposed to wait until early hours of the morning to count and then declare;
	Increasing popularity of the postal vote – the uptake in postal votes continues to remain high and along with the high return rates gives a better reflection of the preferences of Orkney's electorate;
	Mainland Polling Station – a ballot box is always available on the Mainland for any of the outer isles electorate who still prefer to vote in person on polling day;
	Staffing – the availability of staff for all the island polling stations can be quite problematic, along with training with regards to the different legislation now applied. At present all polling staff are experienced Council staff and training and the time taken arranging for suitable

staff to attend on the islands would mean two nights subsistence on top of their fees. This can obviously prove very problematic if any members of staff are off sick at short notice on the week of the Election. The current fees for staff attending a Polling Station is in the region of £555 per polling station for one Presiding Officer and one Polling Clerk. The fees for providing polling staff for all outer isles would mean a cost in the region of £5,500 with travel and subsistence on top.
Harbour Launches – the cost of hiring harbour launches in order to collect the ballot boxes from each of the islands would be in excess of £2100 for first 4 hours following by hourly rate of £530.62. For both the North and South outer isles we would require 2 launches therefore a cost in excess of £6,000.
Risk – Weather related delays, unavailability of harbour launches, due to visiting tankers, and risk of handling ballot boxes at piers have to be noted and taken as "red" risks, which could ultimately delay the security and counting of the votes into the next working day.
Budget – The cost of running Scottish and UK Parliamentary Elections are mainly centrally funded although any Local Government Election is through our own budget and with continuing budgetary constraints it would place additional financial strain in order to increase the cost of running the Election to take into consideration the large financial cost of staffing and logistics for collection of the ballot boxes following close of polls.

Hire of suitable Polling Stations – The use of suitable premises to hold a polling station often becomes the local school and therefore this disrupts the running of the school and often means closing the school for the day of poll.
