1. Apologies

The meeting commenced immediately after a public meeting to elect a new Community Council member, and the Chair congratulated Mrs L McQuaid on her appointment, and it was:

2. Election of Office Bearers

Resolved that the shrub overgrowth on the shared pathway for 4 and 5 Whitehall would be brought to the attention of Housing.
