1. Revenue Expenditure Monitoring

After consideration of a report by the Executive Director of Education, Leisure and Housing, copies of which had been circulated, and after hearing a report from the Business Manager, Orkney College, the Sub-committee:

Noted:

- **1.1.** The revenue financial detail in respect of Orkney College for the period 1 April 2017 to 31 January 2018, attached as Annex 1 to the report by the Executive Director of Education, Leisure and Housing, indicating a net overspend of £310,700.
- **1.2.** The explanations given and actions proposed in respect of significant budget variances, as outlined in the Budget Action Plan, attached as Annex 1 to the report by the Executive Director of Education, Leisure and Housing.

3. Further Education Performance Indicators

After consideration of a report by the Executive Director of Education, Leisure and Housing, copies of which had been circulated, and after hearing a report from the Principal, Orkney College, the Sub-committee:

Noted College Performance Indicators in relation to further education for academic year 2016 to 2017, published by the Scottish Funding Council in February 2018, which indicated the following:

- Overall, 78.7% of Orkney College students on full-time courses completed successfully compared with 65.3% in Scotland as a whole, which was an improvement of 4.4% on 2015 to 2016.
- The overall attainment rate for Orkney College students studying on part-time programmes was 95% compared with 77.1% for Scotland as a whole.
