Stromness Golf Club - Enhancements to Stromness Golf Club

Councillor James W Stockan declared a financial interest in this item, in that he was a shareholder in Stromness Golf Club Limited, and was not present during discussion thereof.

After consideration of a report by the Executive Director of Development and Infrastructure, copies of which had been circulated, and after hearing a report from Jordan Low, Economic Development Officer, the Sub-committee:

Noted:

- **2.1.** That Stromness Golf Club had applied for assistance from the Community Development Fund towards enhancements to Stromness Golf Course, in order to improve the experience and accessibility of the course for both members and visitors, at a total estimated eligible cost of £57,580.
- **2.2.** That, in May 2019, Stromness Golf Club secured grant assistance from the Community Development Fund of up to £2,500, amounting to 49% of eligible project costs, towards a feasibility study into the proposed enhancements to Stromness Golf Club.
- **2.3.** That Stromness Golf Club was contributing £2,879 of its own resources towards the project.
- **2.4.** That Stromness Golf Club had applied for match funding, amounting to £25,911, from Sport Scotland towards the project.

Orkney Golf Club – Enhancements to Orkney Golf Club

After consideration of a report by the Executive Director of Development and Infrastructure, copies of which had been circulated, and after hearing a report from Alister Brown, Economic Development Officer, the Sub-committee:

- **3.1.** That Orkney Golf Club had applied for assistance from the Community Development Fund towards enhancements to Orkney Golf Course, in order to improve the experience and accessibility of the course for both members and visitors, at a total estimated eligible cost of £81,189.
- **3.2.** That, in May 2019, Orkney Golf Club secured grant assistance from the Community Development Fund of up to £2,500, amounting to 49% of eligible project costs, towards a feasibility study into the proposed enhancements to Orkney Golf Club.
- **3.3.** That Orkney Golf Club was contributing £4,059 of its own resources towards the project.
- **3.4.** That Orkney Golf Club had applied for match funding, amounting to £36,535, from Sport Scotland towards the project.
