After consideration of a report by the Executive Director of Development and Infrastructure, copies of which had been circulated, and after hearing a report from the Planning Manager (Development Management), the Committee:

**2.1.** That a letter of objection relating to the application for planning permission in respect of the proposal to increase the cage size at an existing salmon farming site at Lyrawa Bay, Scapa Flow, had been received from the Royal Society for the Protection of Birds, Orkney Office, 12 to 14 North End Road, Stromness.

After hearing a statement from the Royal Society for the Protection of Birds, objector, which was read out by the Clerk, and representations from Naomi Dempsey, representing the applicant, Cooke Aquaculture Scotland Limited, Councillor Stephen Sankey, seconded by Councillor Robin W Crichton, moved that planning permission be granted in respect of the proposal to increase the cage size at an existing salmon farming site at Lyrawa Bay, Scapa Flow, subject to conditions as proposed by officers, with the following amendments:

- Condition 13 the words "unless otherwise agreed, in writing, by the Planning Authority" being deleted, to ensure the maximum stocking biomass of 400 tonnes and maximum production biomass of 500 tonnes at the site were maintained at current levels and no unacceptable burden was placed on existing infrastructure.
