- **3.1.** That a premises licence had been held at Pickaquoy Centre and Campus, Muddisdale Road, Kirkwall, since 1 September 2009, firstly by Mark R Harrison and then by Pickaquoy Centre Trust.
- **3.2.** That Pickaquoy Centre Trust had submitted an application for a variation of premises licence held in respect of Pickaquoy Centre and Campus, Muddisdale Road, Kirkwall, which sought approval of updated layout plans to reflect changes to the Centre building by construction of new areas and changed uses of areas within the building carried out within recent years.

 - 11:00 to 01:00 on Thursdays/Fridays to Saturdays/Sundays inclusive.
 - o 12:00 to 00:00 on Sundays.
 - 01:00 any morning for private functions; when an event related to a local festival is being held within the premises; or for the festive season.
- Off-sale operating hours:
 - 11:00 to 22:00 on Mondays to Saturdays inclusive.
 - o 12:00 to 22:00 on Sundays.
- **4.3.** That K H Orkney Ltd had submitted an application for a variation of premises licence held in respect of Kirkwall Hotel, Harbour Street, Kirkwall, which sought the following:
- Inclusion of outdoor area, on the pavement adjacent to the premises, within the premises licence.
- Provision of outdoor drinking facilities during the hours of 11:00 to 22:00 daily.
- Increase to the on-sale capacity of the premises by 24 persons, from 398 to 422, with the inclusion of the outdoor area.
- Increase to areas accessible by children and young persons with the inclusion of the outdoor area.
- Amendment to on-sale operating hours on Sundays, from 10:00 to 00:00.
- Amendment to off-sale operating hours on Sundays, from 10:00 to 22:00.
