1. Apologies

Resolved to note that apologies for absence had been received from Councillors S Clackson, G Sinclair and K Woodbridge.

2. Stronsay 5G Trial - Presentation

The Chair welcomed representatives from the BBC, Cloudnet and Orkney Islands Council who provided members with details of a proposed 5G trial about to take place in Orkney, and it was:

Resolved to note the information presented to members.

3. Adoption of Minutes

The minute of the meeting held on 27 August 2018 was approved, being proposed by Mr P Riley and seconded by Mr S Weaver.

4. Matters Arising

A. Community Resilience Plan

Members heard that additions were being made to the draft Community Emergency Plan, that a quote had been received for the stand by generator link up and that a grant had been awarded for a satellite telephone connection and, following discussion, it was resolved:

- 1. To note the information.
- 2. That on completion the draft Community Emergency Plan would be forwarded to emergency service providers for comment.
- 3. That additional quotes would be requested for the installation of the standby generator.
- 4. That the grant offered for the installation of a satellite telephone be declined.
- 5. That a letter of support would be written in favour of the Stronsay Community Association's grant application for an improved communication network.

B. Village Post Box

Members heard that the village post box had been relocated, and it was:

Resolved to note the information.

C. Unsafe Headstones

Members heard that further communication had been received on the headstone inspection process, and it was:

Members heard that the Community Council Conference due to have been held on 1 October 2018 had been rescheduled to 7 November 2018, and it was:

E. Removal of Redundant Street Lighting

In response to a request for additional information on the proposed removal of a redundant street light within Whitehall Village, Members heard that Roads Support had advised that the column was not located on a public road, that it was on a private footpath which was not the responsibility of the Council, and it was:

Members heard that a public consultation on the proposed development of two Atlantic salmon sea farm sites had been arranged for 21 November 2018, and it was:

Members heard that the Sport and Leisure Service Manager had provided information on the recent closure of the Stronsay Healthy Living Centre and Swimming Pool, and it was resolved:

Members heard that the Roads and Environmental Operations Manager had advised that, as far as he was aware, there was no 'policy' for locating, erecting and emptying dog waste bins, and it was resolved:

- 3. That notices advising dog owners of their responsibility to remove dog fouling would be displayed locally.
- 4. That the Chair would supply a receptacle for empty dog poo bags and position this at Mill Bay.

Members heard that arrangements were in hand to invite an ex-service person to lay the wreath at this year's Armistice Day ceremony, and consideration was also given to correspondence received from the Arts Officer regarding arrangements to mark the centenary of the armistice, and it was:

N. Interpretation Centre Artefacts

Members heard that interpretation artefacts could remain stored in their current locations and that it was hoped these could be moved to a container within Woods Yard, once available, and it was:

Resolved to note the information.

O. Air Passenger Information

Members heard that, following liaison with the Stronsay Airfield Coordinator, notices had been displayed advising air travellers of the check in times and baggage weight restrictions, and it was:

Resolved to note the information.

P. Scalpings

Members heard that in response to previously held consultations, thirty-nine tons of scalpings and the associated haulage cost had been approved for Community Council Grant Scheme funding. It had been ordered and would be stored in the north quarry, by kind permission of the landowner, and it was:

Resolved to note the information.

5. Stronsay Slaughterhouse Report

Members heard that following previously held consultations, arrangements were in hand to enter into a two-year electricity supply contract. It was also reported that the main entrance door to the slaughterhouse was in need of repair. Members also heard that a request had been made for information on the use of the slaughterhouse by non-residents and that the Slaughterhouse Operator had verbally tendered his resignation, and it was resolved:

- A. To note the information.
- B. That a 2 year Protect Contract with Scottish Southern Electricity would be opened with quarterly payments by Direct Debit.
- C. That the Chair would inspect and repair the slaughterhouse door.
- D. That the vacancy for a Slaughterhouse Operator would be advertised locally.
- E. That following consultation with the Chair, the Clerk had responded to the request for information on the use of the slaughterhouse by non-residents.

6. Stronsay Fish Mart Report

Members heard that previous consultations had taken place on renewing the electricity supply contract, and to the Operators' request for ten new mattresses. Work had been authorised to supply and fit secondary glazing to the skylights. Following consultation and agreement, new longer curtains had been purchased for use in the public shower room and repairs to the public shower room door had been authorised. Members were also informed that enquiries had been made into grant aid availability to fit PV solar panels on the Fish Mart roof, but that this could not be progressed without additional information being made available, and it was resolved:

- A. To note the information.
- B. That a new two year Protect Contract with the existing electricity supplier, commencing 1 January 2019, would be opened.
- C. That additional information on replacement mattresses would be presented to members and consideration would be given into how many should be replaced and how these should be funded.
- D. That a further request would be made for information on the PV solar panels to be fitted on the Fish Mart roof.

7. Transport Representative's Report

Members heard that the Chair and Transport Representative had attended the Orkney Inter Island Transport Study – Outline Business Case Workshop. A detailed summary of recommendations arising from the study was presented to members, and it was:

Resolved to note the information.

8. Planning Representative's Report

Members heard that their attention had been previously brought to a planning application to erect an agricultural shed. and it was:
