Joint Inspection of Adult Support and Protection – Improvement Plan.

1. Purpose of Report

3. Background

On 20 June 2023, the Policy and Resources Committee noted:

 That, between October 2022 and April 2023, the Orkney Partnership was inspected to ensure that adults at risk of harm in Orkney were safe, protected and supported.

- That, on 4 April 2023, a joint seminar for Elected Members, Integration Joint Board Members and NHS Orkney Board Members was held to provide feedback following receipt of the draft inspection report.
- That, on 11 April 2023, the Care Inspectorate published its report of the joint inspection of adult support and protection, attached as Appendix 1 to the report by the Chief Officer, Orkney Health and Social Care Partnership.
- The key findings arising from the inspection report, summarised in section 4 of the report by the Chief Officer, Orkney Health and Social Care Partnership.
- That work was progressing to develop the improvement action plan which would be presented to the next meeting of the Policy and Resources Committee, together with a progress update.
