# **Value and Support Unpaid Carers**

A dementia strategy should have been presented to the Board on 9 April 2020 but that Board meeting was stripped down and was voting members only. There is a report to rescind delegated powers at this meeting and Board meetings will continue to take place as prior to the COVID 19 emergency pandemic measures, albeit virtually.

This strategy was being presented by Changing Lives Trust and Age Scotland. We will work with our colleagues to ensure this can be presented at the June Board meeting.

The partnership has worked closely with Crossroads and other colleagues to ensure that we can ensure that unpaid carers are appropriately supported in their role during the COVID 19 emergency. This has included the supply of appropriate PPE through the supplies that the partnership receives via NSS.
