1.	Welcome & Apologies	Noted as above.		
2.	Island Wellbeing Project	<ul> <li>Harry Johnston presented the results of an Island Wellbeing survey, which aimed to map and understand the health, economic and social wellbeing of residents in Orkney's non-linked isles. He explained that the project is a partnership between Voluntary Action Orkney (VAO) and the Development Trusts of Hoy, Stronsay, Sanday, Shapinsay and Rousay, Egilsay and Wyre. Each island has a Community Wellbeing Co-ordinator who develops new groups and projects and provides one-to-one support where needed.</li> <li>Following the presentation feedback was sought from the Strategic Planning Group (SPG). Dawn Moody expressed her thanks for a brilliant presentation and made reference to her frailty project and the huge wealth of data from the isles. She particularly noted the key role of the Wellbeing Co-ordinators and suggested further discussion</li> </ul>

		outwith the meeting.		
		Following a question as to whether there was a link to the data, Harry advised that whilst he was waiting for the finalised report, he would circulate the link to SPG.		
		It was asked how easy it would be to access agencies to help with food and financial insecurity, and Harry advised that a community led food dignity strategy was being developed, although the pressure that services were under was leading to delays. A further question was in relation to funding from SG for allowances and whether there is a network where people can seek help filling in forms, to which Harry confirmed there is support available although resource intensive.		
		In relation to unemployment rates it was asked whether there was information on available employment or the individual's skills and readiness for employment. Harry advised he was not able to advise on that in an informed way, but that he was aware some work was being done around this by the community learning and development team.		
		It was noted that the data highlighted areas where people might experience inequalities in these communities.		
		Maureen Swannie advised the need to write up and publish an Orkney version of a compassion project. She noted there was no linkage between the different people going out and asked how do we ensure the Wellbeing Co-ordinators, council staff and community link workers

		attached to GP Practices tie their resources together. She expressed the hope that working with Harry would help inform locality planning and looked forward to working with him.		
		It was noted that the presentation contained a lot of concise data and wondered whether the response would have been as successful if the island Wellbeing Co-ordinators were not in situ. Harry was asked what the plans are moving forward, as the project feeds in well with other strategic priorities. Was the aspiration for the project to be based on all ferry linked isles, as SPG would be keen to look at ways the Integration Joint Board (IJB) can assist regarding funding.		
		In summary, the Chair advised it was about the joining up of the different projects and ensuring resources are best used. About parity and equity across all the isles groups. Whether there is good practice for others to learn from some communities but also about outcomes and what we can achieve. What are the issues regarding computer technology; is it connectivity, skills, equipment. The Chair thanked Harry for his presentation and hoped to revisit this subject once the report was available.
