1. Disclosure of Exempt Information

2. Suspension of Standing Orders

The Committee **suspended Standing Order 8.11** to enable members to participate in the meeting from a remote location, as a party had the right to be heard in person or through a representative and the decision to be made was as a result of a quasi-judicial or regulatory hearings process, such as a planning application or an appeal.

3. Civic and Miscellaneous Licensing – Functions Report

After consideration of a report by the Corporate Director for Strategy, Performance and Business Solutions, copies of which had been circulated, and after hearing a report from the Solicitor, the Committee:

Noted the report in relation to the exercise of the Council's functions in terms of the Civic Government (Scotland) Act 1982 and the Cinemas Act 1985, for the period from 1 July 2022 to 30 June 2023, attached as Appendix 1 to the report by the Corporate Director for Strategy, Performance and Business Solutions.
