14. Byelaws Regulating Consumption of Alcohol in Public Places

After consideration of a report by the Chief Executive, copies of which had been circulated, and after hearing a report from the Head of Legal Services, the Council:

Noted:

- **14.1.** That, on 14 January 2021, the Council resolved that the Chief Executive should commence a consultation process in order to seek the views of the undernoted organisations to determine whether the existing byelaws prohibiting the consumption of alcohol in designated public places in Kirkwall should be amended, revoked or continued in their present form:
- Police Scotland.
- The Crown Office and Procurator Fiscal Service.
- Kirkwall and St Ola Community Council.
- Other relevant groups such as the Orkney Local Licensing Forum.
- **14.2.** That the first stage of consultation had been carried out in relation to the statutory 10-year review of the Prohibition of Consumption of Alcohol in Designated Public Places (Kirkwall) Byelaws 2011, with responses indicating that the terms of the existing Byelaws continued to be relevant and appropriate.
- **14.3.** That Police Scotland had indicated that it might be useful to have similar Byelaws covering other localities in Orkney.
- **14.4.** That there may be merit in expanding the area to which the Byelaws applied, to correspond with the expansion of housing provision on the outskirts of Kirkwall in accordance with the Local Development Plan.

14.5. That the Scottish Government had been consulted on the Byelaws, including potential amendments to the map describing the designated area to which the Byelaws would apply, and that a response was awaited.

The Council resolved:

- **14.6.** That the existing terms of the Orkney Islands Council Prohibition of Consumption of Alcohol in Designated Public Places Byelaws (Kirkwall) 2011 should remain unchanged, apart from the potential addition of a written description to accompany the map.
- **14.7.** That the map, attached as Appendix 1 to this Minute, be adopted as the new map to accompany the byelaws.
- **14.8.** That, subject to obtaining a satisfactory response from the Scottish Government, the Byelaws Regulating the Consumption of Alcohol in Public Places (Kirkwall) be submitted to full public consultation in accordance with section 202 of the Local Government (Scotland) Act 1973.
- **14.9.** That the Chief Executive should submit a report, to the General Meeting of the Council to be held on 5 October 2021 or as soon as possible thereafter, detailing the outcome of the full public consultation.

15. Nomination for Honour of Freedom of Orkney

After consideration of a report by the Chief Executive, copies of which had been circulated, and after hearing a report from the Head of Executive Support, the Council:

Noted:

- **15.1.** That, in December 2011, the Council adopted a nomination process for conferring the honour of the Freedom of Orkney.
- **15.2.** That a nomination, supported by six elected members, had been received from Councillor J Harvey Johnston, requesting that the Council confer the Freedom of Orkney upon the Royal Navy Northern Diving Group, in recognition of the longstanding historic connection in commemorating those lost in the sinking of HMS Royal Oak and in keeping the community safe through the safe disposal of modern and historic ordnance, including torpedoes and mines.

The Council resolved:

15.3. In terms of section 206(1) of the Local Government (Scotland) Act 1973, to confer the Freedom of Orkney upon the Royal Navy Northern Diving Group in recognition of the connections referred to in paragraph 15.2 above.
