Subject: Climate Change Duties.

1. Summary

1.1. The Scottish Government requires Integration Joint Boards to prepare a report on compliance with climate change duties.

2. Purpose

2.1. To provide members with sight of the Orkney Integration Joint Board's Climate Change Duties report ahead of submission to Scottish Government.

3. Recommendations

The Integration Joint Board is invited to note:

3.1. The statutory duty to prepare a report on compliance with climate change duties.

It is recommended:

3.2. That the Climate Change Duties report, attached as Appendix 1 to this report, be approved for submission to Scottish Government by the deadline of 30 November 2021.

4. Background

- 4.1. The Climate Change (Scotland) Act 2009 and the subsequent Climate Change (Duties of Public Bodies: Reporting Requirements) (Scotland) Order 2015 requires significant public bodies to prepare a report on their compliance with climate change duties. This includes 'An integration joint board established by order under section 9(2) of the Public Bodies (Joint Working) (Scotland) Act 2014(c)'.
- 4.2. Integration Joint Boards (IJBs) are required to submit the report on or before 30 November.

- 4.3. The climate change duties report is to a Scottish Government prescribed standard template, identical to that for all public bodies, such as local authorities and NHS boards, including Orkney Islands Council and NHS Orkney. As a consequence, the Guidance accompanying the 2015 Order recognised that much of the standard report template related to the policies, procedures and services of the local authority and NHS board, rather than IJBs. As such, it was further recognised in the Guidance that there would be a significant degree of proportionality in completion of the report.
- 4.4. Almost all of the report relates to policies and emissions associated with the employment of staff, ownership and occupation of buildings, plant and vehicles, and the delivery of services. As a consequence, the content of the report is very limited. As noted above, Scottish Government recognises this in the Guidance issued to health and social care partnerships.
- 4.5. At its meeting on 29 October 2020, the IJB expressed its frustration with the need to complete a zero return, each year. At the request of the IJB, the Interim Chief Officer wrote to Scottish Government, in December 2020, expressing the IJB's frustration, and requesting consideration be given to exempting IJBs from completing a Climate Change Reporting Return.
- 4.6. Scottish Government's reply acknowledged the IJB's frustration, advised that this would be given further consideration, but, in the meantime, IJBs would have to continue to make the annual return.
- 4.7. The Climate Change Duties report, attached as Appendix 1 to this report, covers the reporting period 1 January to 31 December 2020.
