Vacancies on Committees and Sub-committees.

Report by Chief Executive.

1. Purpose of Report

To consider governance arrangements and appointments to various Committees and Sub-committees.

2. Recommendations

The Committee is invited to note:

2.1.

That Councillor Graham L Sinclair has intimated a wish to reduce his commitments, including demitting his position on the following Committees and Sub-committees:

- Planning Committee and Local Review Body.
- Asset Management Sub-committee.
- Human Resources Sub-committee and Staff Appeals Sub-committee.
- Investments Sub-committee and Pension Fund Sub-committee.

2.2.

That, in terms of the constitutional arrangements of the Planning Committee, Councillor Stephen G Clackson, being the third member of the North Isles electoral ward, should fill the vacancy created by Councillor Sinclair's resignation.

2.3.

The options available for filling the vacancy, summarised as follows, should Councillor Clackson decline the appointment to the Planning Committee:

- Option 1 amend the constitutional arrangements to "at least one member" from each electoral ward and make an appointment, noting the implications for the three 3 member wards.
- Option 2 make no appointment, thereby reducing membership of the Planning Committee to 11 members for the period up to May 2022.

2.4.

That, as membership of the Local Review Body is the same as the Planning Committee, whoever is appointed to the vacancy on the Planning Committee will also serve on the Local Review Body.

2.5.

That, should no appointment be made to the Planning Committee, the Local Review Body would also be reduced to 11 members for the period up to May 2022.

2.6.

That appointments made to fill the vacancies on the various Sub-committees will last for the remainder of the term of this Council, namely until May 2022.

It is recommended:

2.7.

That Councillor Stephen G Clackson be appointed to the Planning Committee and Local Review Body for the period to May 2022.

2.8.

That, should Councillor Clackson decline the appointment referred to above, members should consider the options at paragraph 2.3 above and determine the matter accordingly.

2.9.

That appointments be made to the vacancies on the undernoted sub-committees:

- Asset Management Sub-committee from the list of members at section 5.5 of this report.
- Human Resources Sub-committee and Staff Appeals Sub-committee from the list of members at section 6.3 of this report.
- Investments Sub-committee and Pension Fund Sub-committee from the list of members at section 7.4 of this report.

3. Background

3.1.

Councillor Graham L Sinclair has intimated a wish to reduce his commitments, including demitting his position on the following Committees and Sub-committees:

- Planning Committee and Local Review Body.
- Asset Management Sub-committee.
- Human Resources Sub-committee and Staff Appeals Sub-committee.
- Investments Sub-committee and Pension Fund Sub-committee.

3.2.

Filling the vacancy created on the Planning Committee and the Local Review Body is considered in section 4 below.

3.3.

The Sub-committees referred to above are all sub-committees of the Policy and Resources Committee, therefore consideration can be given to filling the vacancy created by Councillor Sinclair stepping down. Constitutional arrangements and existing membership are detailed in the corresponding sections below.

4. Planning Committee and Local Review Body

4.1.

In July 2018, following a governance review, Council amended the constitutional arrangements in respect of the Planning Committee, from 12 members of the Council, to two elected members from each of the six electoral wards.

4.2.

The reason for this change was that, for the period 2015 to 2017, all four members representing the West Mainland electoral ward were appointed to the Planning Committee. Consequently, an applicant for, or an objector to, a planning application relating to a proposed development in the West Mainland area could not raise any concerns with those members, as it would require those members to then declare an interest and remove themselves from the meeting at which the application was being considered, in accordance with the terms of the Councillors' Code of Conduct.

4.3.

In May 2017, Councillors Graham L Sinclair and Kevin F Woodbridge were appointed as the North Isles representatives on the Planning Committee. These appointments were reaffirmed in May 2019.

4.4.

In terms of the constitutional arrangements of the Planning Committee, Councillor Stephen G Clackson, being the third member of the North Isles electoral ward, should, therefore, fill the vacancy created by Councillor Sinclair's resignation.

4.5.

Should Councillor Clackson decline that appointment, consideration could be given to further reviewing the constitutional arrangements of the Planning Committee. Rather than two representatives from each electoral ward, one option would be to amend to "at least one member".

4.6.

However, with Orkney Islands Council comprising three 3 member wards and three 4 member wards, should a member from one of the 3 member wards be appointed, this would result in the same situation pre-2017, whereby all members of that electoral ward would be members of the Planning Committee.

4.6.1.

Appointing a member from one of the 4 member wards would result in the remaining member from that ward not serving on the Planning Committee.

4.7.

Another option would be not to fill the vacancy, thereby reducing overall membership of the Planning Committee to 11 members. This could then be reviewed in May 2022, following the ordinary election of members.

4.8.

Current membership of the Planning Committee is as follows:

4.9.

Should Councillor Clackson decline the appointment to the vacancy on the Planning Committee, members are invited to consider the options, summarised as follows:

 Option 1 – amend the constitutional arrangements to "at least one member" from each electoral ward and make an appointment, noting the implications for the three 3 member wards. Option 2 – make no appointment, thereby reducing membership of the Planning Committee to 11 members for the period up to May 2022.

4.10.

As membership of the Local Review Body is the same as the Planning Committee, whoever is appointed to the vacancy on the Planning Committee will also serve on the Local Review Body. Alternatively, should no appointment be made, the Local Review Body would also be reduced to 11 members for the period up to May 2022.

5. Asset Management Sub-committee

5.1.

The Asset Management Sub-committee comprises:

- Chair, Policy and Resources Committee.
- · Vice Chair, Policy and Resources Committee.
- 5 other Members of the Policy and Resources Committee.

5.2.

Existing membership is as follows:

11. Legal Aspects

11.1.

With limited exceptions, section 56 of the Local Government (Scotland) Act 1973 provides that a local authority may arrange for the discharge of any of their functions by a committee of the authority, a sub-committee, an officer of the authority or by any other local authority in Scotland. The discharge of functions also includes doing anything which is calculated to facilitate or is conducive or incidental to the discharge of any of these functions.

11.2.

There are no statutory rules in force in Scotland as to which councillors should be appointed to which committee. Councils have a discretion to decide the membership of their committees and sub-committees.
