1. Purpose of Report

To consider the draft Orkney College UHI Operational Plan 2018 to 2019.

2. Recommendations

It is recommended:

2.1.

That the draft Orkney College UHI Operational Plan 2018 to 2019, attached as Appendix 1 to this report, which contains objectives identified to ensure delivery of the aims of the Strategic Plan 2018 to 2021, be endorsed for delivery.

3. Draft Operational Plan for 2018 to 2019

3.1.

The Orkney College Strategic Plan 2018 to 2021 sets out the strategic priorities of the College over a three year period. As circumstances and priorities are likely to change over this time period, it is good practice to set strategic objectives and targets annually and review the strategic plan as a whole on an annual basis.

3.2.

The Orkney College UHI Strategic Plan for 2018 to 2021 was endorsed for delivery by the College Management Council at its last meeting held on 28 May 2018.

3.3.

The draft Operational Plan for Orkney College is a key document that sets out the work that will be undertaken to deliver the relevant elements of the Strategic Plan over a 12 month academic year period. The draft Operational Plan for 2018 to 2019 is attached as Appendix 1 to this report.

4. Human Resource Implications

Although there are no direct Human Resource implications arising from this report, given the identified priorities within the Operational Plan there is the potential for Human Resource issues to arise, although they cannot be anticipated at this stage.
