#### Comment.

The introduction of an EMDR (Eye Movement Desensitisation and Reprocessing) Nurse therapist and CAAP (Clinical Associate in Applied Psychology) worker has widened the scope of care and treatment available in Orkney. In addition, CAMHS (Child and Adolescent Mental Health Service) has introduced a Choices Assessment Clinic allowing young people to be assessed quicker by assigning cases to the appropriate practitioner immediately following assessment. CAMHS offers regular consultations within schools as well as providing training for other agencies in relation to mental health in young people which has been well received. CAMHS has however received resignations recently and we are in the process of recruiting to the vacant posts, agency staff have been sourced to minimise the impact. We are currently consulting on a mental health strategy which will take account of the views of young people.

A further Consultative Group meeting (joint between Roads and Environmental Services and Planning and Regulatory Services) was held on 15 March 2019, this highlighted mixed views on whether to proceed with a car parking / EHO enforcement model and equally to advance Decriminalised Parking Enforcement (DPE) noting the need to be self-financing. It was agreed that further work be done on developing the DPE business case which is underway in the 2019 to 2020 financial year.
