**Burial Ground Charges.** 

Report by Executive Director of Development and Infrastructure.

# 1. Purpose of Report

To consider removal of burial charges for children under 18 years old.

### 2. Recommendations

The Committee is invited to note:

#### 2.1.

That most local authorities in Scotland have no charge policies in place for child burials and cremations.

### 2.2.

The Council's burial ground charges, as detailed in section 3.2 of this report.

### 2.3.

That the Convention of Scottish Local Authorities and the Scottish Government have made a joint commitment to remove local authority fees in respect of burials and cremation of children under 18 years old, as detailed in section 4 of this report.

#### It is recommended:

### 2.4.

That burial charges be waived for children under 18 years old, in accordance with the joint commitment made by COSLA and the Scottish Government.

# 3. Background

### 3.1.

While most local authorities already have no charge policies in place for child burials and cremations, there is a mixed picture across Scotland in terms of the age at which adult burial and cremation fees begin to be levied.

#### 3.2.

Orkney Islands Council's burial ground charges for 2018 to 2019 are as follows:

- Reservation of a lair £605.
- Excavation of a grave £553.
- Excavation of a grave for a casket £160.
- Excavation of a grave for an infant/child up to 16 years old Nil.

#### 3.3.

Although all excavation charges are currently waived for burials of children up to 16 years old, the reservation of a lair charge applies to all age groups. Therefore, there would be a reservation and excavation charge for the burial of a 17 year old under the current system.

#### 3.4.

Historically the Council undertakes a small number of child burials per year. The table below shows the number of burials of children under the age of 18 from 1 January 2008 to 30 September 2018.

Date	No. of Burials of children under 18 years old
2009	3 burials
2012	2 burials
2015	2 burials
2016	1 burial
Total burials in 10 years	8 burials

### 4. Commitment to Remove Fees

#### 4.1.

COSLA and the Scottish Government have made a joint commitment to remove local authority fees for burials and cremations for children under 18 years old. This was agreed through the COSLA Leaders meeting in May 2018.

#### 4.2.

COSLA officers have provided clarity to local authority contacts, Chief Executives and Directors on the detail of the agreement, including the funding which Scottish Government is providing, as detailed in section 7.1 of this report, and an expectation that local policy and practice changes will be implemented by October 2018.

#### 4.3.

Orkney falls into the category of not formally ratifying changes by October, and COSLA asks that local authorities, such as Orkney, implement the principles of the agreement on a case by case basis in the interim period to ensure that bereaved

parents receive support from this agreement as swiftly as possible to obtain consistency throughout Scotland.

#### 4.4.

It is proposed that all burial charges should be waived for children under 18 years old. A policy or guidelines should be put in place so that any future interments in a child's lair would be for children only.

# 5. Equalities Impact

An Equality Impact Assessment has been undertaken and is attached as Appendix 1 to this report.

# 6. Corporate Governance

This report relates to the Council addressing a national commitment and therefore does not directly support and contribute to improved outcomes for communities as outlined in the Council Plan and the Local Outcomes Improvement Plan.

# 7. Financial Implications

#### 7.1.

Financial support of £310,000 per annum to Scottish local authorities has been agreed with COSLA leaders. The distribution to local authorities will be determined by the population of 0 to 18 year olds in each local authority area. This was agreed at the Settlement and Distribution Group (SDG) meeting between the Scottish Government and COSLA. Orkney has approximately 0.4% of Scotland's population for this age category which equates to a distribution of £1,200 per annum for Orkney.

### 7.2.

Based on the information set out in Section 3 to this report, the additional funding would be sufficient to offset the full charges at £1,158 for 1 burial per annum. As such, the recommendations to this report are considered to be cost neutral.

# 8. Legal Aspects

There are no legal implications directly arising from the recommendation of this report. If the recommendation is not agreed, there may be legal implications arising from the Council's participation in COSLA.
