4. Review of Statement of Alcohol Licensing Policy – Overprovision

4.1. That the Board's current Statement of Alcohol Licensing Policy, adopted on 5 December 2013, required review during 2018.

4.2. That the Statement of Alcohol Licensing Policy must, in particular, include a statement as to the extent to which the Board considered there to be overprovision of licensed premises or licensed premises of a particular description in any locality within the Board's area.

4.3. That the first stage of the process in updating the Statement of Alcohol Licensing Policy was for the Board to determine the locality or localities for the purpose of consultation on the assessment of overprovision.

4.4. That the locality for the purpose of assessing overprovision could be the whole Board area.

The Board resolved:

4.5. On the motion of Steven B Heddle, seconded by J Harvey Johnston, that, for the purposes of consultation on the assessment of overprovision of alcohol licensed premises, the locality should be Orkney as a whole.

4.6. That the Clerk to the Board should undertake statutory consultation on whether or not there was overprovision of alcohol licensed premises within the locality determined by the Board, namely Orkney as a whole.

4.7. That the Clerk to the Board should submit a report, to the meeting of the Board to be held on 3 May 2018, on the outcome of the consultation, referred to at paragraph 4.6 above.
