Aeronautical Information

- a) The declared distances contained within the Aeronautical Information Publication (AIP) entry do not reflect the distances produced from the recent surveys.
- b) The aerodrome has Aeronautical Ground Lighting (AGL) which they utilise during the day only to aid pilots and for which they have permission to use at night only for the purposes of air ambulance flights. Section AD 2.14 'Approach and Runway Lighting' in the AIP entry does not contain any information on the AGL available at the aerodrome.

Observation: Aerodrome Emergency Planning

The recent aerodrome terminal building development has resulted in the airfield emergency vehicle access gate being relocated, as a result the ground marking which prevent unauthorised parking is to be refreshed.

The Difficult Environs assessment was last conducted in 2014. Consideration should be given to revisiting the assessment.

Consideration should be given to revising the aircraft accident report form. Guidance on the content is contained within CAP 168.

#### Details

Observation - Obstacle Limitation Surfaces

- (a) During the airfield inspection a tractor with it's bucket raised was seen driving on a road just outside the airfield boundary prior to the runway 29 threshold. Vehicles on roads are considered to be 4.8m maximum height and it was unclear from survey data if vehicles using roads were included in the obstacle survey. This may also apply to other Orkney Council airfields.
- (b) All runway declared distances have a TODA value exceeding TORA therefore a clearway is provided. When a clearway is provided the length of the inner edge of the take-off climb surface (TOCS) should be 150m (75m either side of the runway extended centreline). It was unclear from survey data if this criteria was being applied. If the TODA is the same value as TORA then there is no clearway and the TOCS inner edge length is 60m (30m either side of the runway extended centreline). This may also apply to other Orkney Council airfields.

## **Definition of Findings**

## LEVEL 1 (ONE) NON-COMPLIANCE CREATING A SIGNIFICANT SAFETY HAZARD

Level 1 items will be reported to the Accountable Manager for action if a major failure of compliance has been identified with the aerodrome licensing requirements set out in either the Air Navigation Order, the Aerodrome Licence, ICAO Annex 14 or Civil Aviation Publication (CAP) 168.

If any Level 1 items are reported, the major failure of compliance must be rectified immediately or within the short timescales indicated. Failure to do so will result in the CAA having to take regulatory action, which could result in suspension of the Aerodrome Licence.

## LEVEL 2 (TWO) NON-COMPLIANCE

Level 2 items will be reported to the Accountable Manager for action if it has been identified that the Aerodrome is not in full compliance with the aerodrome licensing requirements set out in either the Air Navigation Order, the Aerodrome Licence, ICAO Annex 14, Civil Aviation Publication (CAP) 168 or the Aerodrome Manual.

If any Level 2 items are reported, the CAA Aerodrome Oversight team must be informed that these items have been rectified by the dates agreed with the aerodrome during the inspection, and shown in the Latest Correction Date box. Failure to rectify any items within the agreed time scale may result in the CAA having to take regulatory action, which could result in suspension of the Aerodrome Licence.
