1. Suspension of Standing Orders

2. Form of Voting

The Committee resolved that, should a vote be required in respect of the planning applications to be considered at this meeting, notwithstanding Standing Order 21.4, the form of voting should be by calling the roll (recorded vote).

3. Planning Application 20/112/TPP

Proposed Erection of Two Wind Turbines, Substation, Hydrogen Production Facility and Associated Infrastructure at Hammars Hill, Evie

Alistair Gray and Rob Collin, representing the applicants, Hammars Hill Energy Limited and Eneus Energy Limited respectively, were present during consideration of this item.

After consideration of a report by the Executive Director of Development and Infrastructure, copies of which had been circulated, and after hearing a report from the Planning Manager (Development Management), the Committee:

Noted:

3.1. That letters of objection relating to the application for planning permission in respect of the proposal for the erection of two wind turbines, a substation, a hydrogen production facility and associated infrastructure at Hammars Hill, Evie, had been received from the following:

- Jim and Maureen Leitch, Feolquoy, Evie.
- RSPB Scotland, Orkney Office, 12-14 North End Road, Stromness.

After hearing a statement from Jim and Maureen Leitch, objectors, which was read out by the Clerk, and after hearing representations from Alistair Gray and Rob Collin, representing the applicants, Hammars Hill Energy Limited and Eneus Energy Limited respectively, Councillor Robin W Crichton, seconded by Councillor David Dawson, moved that the application for planning permission in respect of the proposal for the erection of two wind turbines, a substation, a hydrogen production facility and associated infrastructure at Hammars Hill, Evie, be deferred to enable members of the Committee to undertake an unaccompanied site visit.

Councillor John A R Scott, seconded by Councillor Stephen Sankey, moved an amendment that planning permission be granted in respect of the proposal for the erection of two wind turbines, a substation, a hydrogen production facility and associated infrastructure at Hammars Hill, Evie, subject to conditions as proposed by officers.

- A planning obligation, financial bond and/or other financial provision, to ensure that decommissioning and reinstatement would be completed, at the cost of the developer.

3.3. That powers be delegated to the Executive Director of Development and Infrastructure, in consultation with the Head of Finance and the Head of Legal Services:

- To determine the appropriate planning obligation, financial bond and/or other financial provision, to ensure completion of decommissioning and reinstatement at the cost of the developer.
- To thereafter negotiate and conclude, prior to commencement of development, the necessary planning obligation, financial bond and/or other financial provision.

4. Planning Application 20/301/PIP

Proposed Siting of Four Houses on Land near Burnbank, Burray

Leo Kerr, applicant, and John Orr, objector, were present during consideration of this item.

After consideration of a report by the Executive Director of Development and Infrastructure, copies of which had been circulated, and after hearing a report from the Planning Manager (Development Management), the Committee:
