1. Apologies

Resolved to note that apologies for absence had been received from Mr J Seaton.

2. Adoption of Minutes

The minute of the meeting held on 25 March 2024 was approved, being proposed by Mr S Hourston and seconded by Mr D Blyth.

3. Election of Office Bearers

Resolved that this be deferred to the next meeting of Stronsay Community Council.

4. Matters Arising

A. Village Play Park

Members heard that a Teams meeting with officers from Orkney Islands Council and the Clerk had taken place and requests had been received from the Assistant Project Officer, Orkney Islands Council Crown Estates Community Led Development Fund, for progress updates on the Play Park Project, and that communication was on-going between the Team Manager – Sport and Leisure and officers following which a further meeting would be reconvened, and it was:

Resolved to note the information provided.

B. Scrap Vehicles

Members heard that since the last Stronsay Community Council meeting all five places for disposal of vehicles under the Scrap Car Scheme had been allocated and removed and following consideration members agreed to reopen the scheme for a further six vehicles. Members also considered using an alternative disposal provider, and it was:

Resolved:

1. To note the information provided.

2. That if delays continued in disposing of the vehicles alternative arrangements would be reconsidered.

C. Winter Service Plan 2024

Members heard that their concern over the condition of the ground in the Leaquoy cemetery and a request for the installation of gravel or concrete pathways had been forwarded to the Burial Grounds Officer who would assess the condition of the ground nearer the time the cemetery was due to come into use, and that there were no plans to install paths, and it was:

G. Matpow Sluice

Members heard that Roads had confirmed they were aware of the damage to the Matpow sluice and were looking at the best option to proceed, and it was:

I. Rothiesholm Beach Car Park Road

Members heard that aggregates had been provided by Stronsay Community Council and that the Access Officer, Roads had arranged for the Isles Operative to fill in the potholes on the Rothiesholm beach road, and it was:

J. Lifeboat Slipway

Members heard that following email liaison between officers and Stronsay Community Council, an officer from Building Standards visited the lifeboat slipway and concluded no further action was necessary at the present time by them but that members could probably engage with the slipway owners to discuss their concern, and it was:

K. Daffodils on Verges Proposal

Members considered a proposal to once again offer residents free daffodil bulbs for planting in verges, and it was:

Resolved:

1. That members agreed to the purchase of three, twenty-five-kilogram nets of daffodils to be issued free of charge to residents to plant in a verge in front or their property, subject to Community Council Grant funding approval.

2. That the Clerk would organise the purchase and distribution of daffodil bulbs.

L. TRI-CE Meeting

Members heard that the Community Learning, Development and Employability Service Manager had offered TRI-CE meetings to get the Community Association, Community Council and the Development Trust working better together and coordinate their work, and it was:

7. Slaughterhouse Report

Members heard that an invoice had been received for the removal of the old hoist, that invoices had been received for electricity usage between 21 January and 21 July 2024, and the electricity supplier had offered to fit a smart meter, and it was:

A. That payment for the removal of the old hoist would be from the Stronsay slaughterhouse account.

B. That a smart meter had been declined as it would not be possible to include a coin operated facility currently used by slaughterhouse users.

8. Fish Mart Report

Due to the sensitive content of the following item, it was held in committee.

Members heard that the Fish Mart Subgroup had met with the operators to discuss maintenance issues and requests for new items, including a wheelie bin. Occupancy figures for the last two quarters had been received and forwarded to members.

The terms of the lease had been discussed, along with responsibility regarding planned closures. Broadband, telephone and hydro contracts were discussed and a transfer of £2,000 from the general fund to the Stronsay Community Council account had been agreed to meet future direct debit payments.

Members had also been previously consulted and had agreed to purchase a new fridge for use in the Hostel kitchen and to dispose of the old one in August's special collection. Following further discussion, it was:
