

**THE ORKNEY ISLANDS COUNCIL (STROMNESS) (PROHIBITION OF WAITING)
ORDER 201[]**

Orkney Islands Council in exercise of its powers under Sections 1(1), 2(1) to (3) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”), and of all other enabling powers, and after consultation with the chief officer of the police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:-

1. This Order may be cited as The Orkney Islands Council (Stromness) (Prohibition of Waiting) Order 201[] and shall come into operation on []
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Save as provided in Articles 8, 9 and 10 of this Order no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to wait at any time in any of the lengths of road specified in Schedule 1 to this Order.
4. Save as provided in Articles 8 and 9 of this Order no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to wait between the hours of 9am and 5pm on Mondays to Saturdays inclusive in any of the lengths of road specified in Schedule 2 to this Order.
5. Save as provided in Articles 8 and 9 of this Order no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to wait for a period exceeding 30 minutes in any one hour between the hours of 9am and 5pm on Mondays to Saturdays inclusive in any of the lengths of road specified in Schedule 3 to this Order.
6. Where, in any length of road referred to in Schedule 4 to this Order, there are road markings in accordance with The Traffic Signs Regulations and General Directions 2016 indicating the limits of a parking space provided for the leaving of one disabled person’s vehicle, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to wait at any time in that parking space unless said vehicle has been left entirely within the limits of the road markings and displaying in the relevant position a disabled person’s badge issued by a local authority.
7. Where, in any length of road referred to in this Order, there are road markings in accordance with The Traffic Signs Regulations and General Directions 2016 indicating the limits of a parking space provided for the leaving of one vehicle, no person shall, except upon the direction or with the permission of a police officer in

uniform, cause or permit any vehicle to wait at any time in that parking space unless said vehicle has been left entirely within the limits of the road markings.

8. Nothing in Articles 3, 4 and 5 of this Order shall prevent any person from causing or permitting a vehicle to wait in any of the lengths of road referred to in those Articles for so long as may be necessary:-
 - a) to enable a person to board or alight from the vehicle; or
 - b) to enable goods to be loaded on to or unloaded from the vehicle; or
 - c) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred to, or the laying, erection, alteration or repair in or near to any of the said lengths of road of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any telecommunication apparatus as defined in Schedule 2 to the Telecommunications Act 1984; or
 - d) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers and duties.
9. Nothing in Articles 3, 4 and 5 of this Order shall apply to a vehicle lawfully displaying, in the manner prescribed by Regulation 12 of the Disabled Persons (Badges for Motor Vehicles) (Scotland) Regulations 2000, a disabled person's badge as defined in Regulation 2(1) of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 2002 and not causing an obstruction.
10. Nothing in Article 3 of this Order shall prevent any person from causing or permitting any vehicle to wait -
 - a) in the five parking spaces on the eastsoutheast and southeast side of A965 Dundas Street, Stromness, specified in paragraphs a), b) and c) of Schedule 5 and shown in red on Plan 3;
 - b) in the twenty five parking spaces on the south and southeast side of unclassified Springfield Crescent, Stromness, specified in paragraphs o), p) and q) of Schedule 5 and shown in red on Plan 3;
 - c) in the thirty three parking spaces on the southeast, east, west and northwest sides of A965 North End Road, Stromness, specified in

paragraphs d), e), f) g), h), i), j) k) and l) in Schedule 5 and shown in red on Plan 1;

- d) in the six parking spaces on the southwest, south and southeast sides of unclassified Hellihole Road, Stromness, specified in paragraphs r) and s) in Schedule 5 and shown in red on Plan 3;
 - e) in the layby on the westnorthwest side of unclassified Ferry Road , Stromness, at the public conveniences lying to the southeast of 8 North End Road, Stromness, provided the said vehicle does not remain in the said layby for a period exceeding thirty minutes in any one hour between the hours of 9am and 5pm on Mondays to Saturdays inclusive, as shown in brown on Plan 1;
 - f) in the twenty three parking spaces on A965 John Street, Stromness, the five parking spaces on unclassified Ferry Road, Stromness, the sixteen parking spaces on A965 Victoria Street, Stromness, the four parking spaces on A965 Graham Place, Stromness and the seven parking spaces on unclassified Church Road, Stromness all of which parking spaces are shown in green on Plans 2 and 3 provided the said vehicle does not remain in any of the said parking spaces for a period exceeding thirty minutes in any one hour;
 - g) in the private parking area outside numbers 30, 32 and 34 North End Road, Stromness which private parking area is shown in purple on Plan 1; or
 - h) in the eight parking spaces on the southeast side of unclassified Franklin Road, Stromness, specified in paragraphs m) and n) of Schedule 5 and shown in red on Plan 3.
11. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by and under any other enactment.
 12. The Orkney Islands Council (Stromness) (Prohibition of Waiting) Order 2000, which came into operation on the First day of September Two Thousand, is hereby revoked.
 13. The Orkney Islands Council (Springfield Crescent, Stromness) (Prohibition of Waiting) Order 2002, which came into operation on the First day of August Two Thousand and Two, is hereby revoked.

14. The Orkney Islands Council (North End Road, Stromness) (Prohibition of Waiting) Order 2014, which came into operation on the Twenty Eighth day of April Two Thousand and Fourteen, is hereby revoked.

Schedule 1

- a) On the north side of C11 Cairston Road, Stromness, from a point sixteen metres or thereby east of its junction with A965 North End Road, Stromness, proceeding in a northwesterly direction on Ferry Road Roundabout, Stromness, for a distance of thirty metres nine hundred millimetres or thereby, as shown in orange on Plan 1.
- b) On the south side of C11 Cairston Road, Stromness, from a point fifteen metres eight hundred millimetres or thereby east of its junction with unclassified Ferry Road, Stromness, proceeding in a south westerly direction on unclassified Ferry Road, Stromness, to its junction with the north side entrance to the Heavy Goods Vehicle parking place on the eastsoutheast side of unclassified Ferry Road, Stromness, a distance of three hundred and ninety eight metres three hundred millimetres or thereby, as shown in orange on Plan 1 and Plan 2.
- c) On the southeast side of unclassified Ferry Road, Stromness, from its junction with the south side of the entrance to the Heavy Goods Vehicle parking place on the eastsoutheast side of unclassified Ferry Road, Stromness, to its junction with the north side of the exit from the Heavy Goods Vehicle parking place on the eastsoutheast side of unclassified Ferry Road, Stromness, a distance of thirty nine metres or thereby, as shown in orange on Plan 2.
- d) On the southeast side of unclassified Ferry Road, Stromness, from its junction with the south side of the exit from the Heavy Goods Vehicle parking place on the eastsoutheast side of unclassified Ferry Road, Stromness, to its junction with the north side of the entrance to the Ferry Terminal parking place, a distance of twenty seven metres or thereby, as shown in orange on Plan 2.
- e) On the southeast side of unclassified Ferry Road, Stromness, from its junction with the south side of the entrance to the Ferry Terminal parking place, Stromness, to its junction with the north side of the exit

from the Ferry Terminal parking place, Stromness, a distance of thirty five metres or thereby, as shown in orange on Plan 2.

- f) On the southeast side of unclassified Ferry Road, Stromness, from its junction with the south side of the exit from the Ferry Terminal parking place, Stromness, proceeding in a southerly direction for a distance of twenty five metres or thereby, as shown in orange on Plan 2.
- g) On the southeast side of unclassified Ferry Road, Stromness, from a point thirty five metres or thereby southsoutheast of its junction with the south side of the exit from the Ferry Terminal parking place, Stromness, proceeding in a southerly direction to its junction with the south side of the entrance to South Pier, Stromness, a distance of seventy six metres or thereby, as shown in Grey on Plan 2.
- h) On the southeast side of unclassified Ferry Road, Stromness, from its junction with the south side of the entrance to South Pier, Stromness, proceeding in a westerly direction for a distance of seven metres or thereby, as shown in grey on Plan 2.
- i) On the southeast side of unclassified Ferry Road, Stromness, from a point one metre five hundred millimetres or thereby northeast of the northeastmost corner of 18 Victoria Street, Stromness, to a point one metre two hundred millimetres or thereby northeast of the northwestmost corner of 20 Victoria Street, Stromness, a distance of eleven metres five hundred millimetres or thereby, as shown in grey on Plan 2.
- j) On the northeast side of unclassified Hillside Road, Stromness, from a point sixteen metres or thereby northwest of its junction with A965 North End Road, Stromness, proceeding firstly in a southeasterly and thereafter in a northeasterly direction and for a distance of fifty six metres or thereby, as shown in orange on Plan 1.
- k) On the northeast side of A965 North End Road, Stromness, from the north side of the entrance to the North End Garage Station, Stromness, proceeding firstly in a northeasterly direction following the curve of the road and thereafter in a southerly direction on the west side of unclassified Ferry Road, Stromness to its junction with the north side of the entrance to the Co-op car park, Stromness, a distance of one hundred and ninety four metres or thereby, as shown in orange on Plan 1.

- l) On the westnorthwest side of unclassified Ferry Road, Stromness, from its junction with the south side of the entrance to the Co-op car park, Stromness, to the north side of the entrance to the Ferry Inn parking place, Stromness, a distance of three hundred and ninety six metres or thereby, as shown in orange partly on Plan 1 and partly on Plan 2.
- m) On the westnorthwest side of unclassified Ferry Road, Stromness, from its junction with the south side of the entrance to the Ferry Inn parking place, Stromness, to its junction with the north side of the entrance to the Library parking place, Stromness, a distance of sixteen metres or thereby, as shown in orange on Plan 2.
- n) On the westnorthwest side of unclassified Ferry Road, Stromness, from its junction with the south side of the entrance to the Library parking place, Stromness, to the southeastmost corner of 16 Victoria Street, Stromness, a distance of ninety three metres six hundred millimetres or thereby, as shown partly in orange and partly in grey on Plan 2.
- o) On the northnortheast side of unclassified Ferry Road, Stromness, from a point at the southwestmost corner of 16 Victoria Street, Stromness, to a point at the southeastmost corner of 16 Victoria Street, Stromness, a distance of twelve metres four hundred millimetres or thereby, as shown in grey on Plan 2.
- p) On the northnortheast side of unclassified Church Road, Stromness, from its junction with A965 Victoria Street, Stromness, to a point one metre one hundred millimetres or thereby eastsoutheast of the southwestmost corner of 1 Church Road, Stromness, a distance of seventeen metres or thereby, as shown in grey on Plan 3.
- q) On the northnortheast side of unclassified Church Road, Stromness, from a point one metre or thereby eastsoutheast of the southwestmost corner of 19 Church Road, Stromness, to a point four metres seven hundred millimetres or thereby eastsoutheast of the southwestmost corner of the Scottish Episcopal Church, Church Road, Stromness, a distance of six metres five hundred millimetres or thereby, as shown in grey on Plan 3.
- r) On the northnortheast side of unclassified Church Road, Stromness, from a point three hundred millimetres or thereby westnorthwest of the southwestmost corner of the Scottish Episcopal Church, Church Road, Stromness, to its junction with unclassified Franklin Road, Stromness, a total distance of fifty five metres five hundred millimetres or thereby, as shown partly in orange and partly in grey on Plan 3.

- s) On the southsouthwest and southeast sides of unclassified Church Road, Stromness, from its junction with A965 Victoria Street, Stromness, to its junction with unclassified Franklin Road, Stromness, a total distance of one hundred and eight metres or thereby, as shown partly in grey and partly in orange on Plan 3.
- t) On the east, southeast and eastsoutheast sides of A965 Dundas Street, Stromness, from its junction with A965 Graham Place, Stromness, to a point two metres or thereby southsouthwest of the northwestmost corner of 52 Dundas Street, Stromness, a total distance of one hundred and one metres or thereby, as shown in grey on Plan 3.
- u) On the east and southeast sides of A965 Dundas Street, Stromness, from a point seven metres or thereby southsouthwest of the northwestmost corner of 52 Dundas Street, Stromness to a point eight metres or thereby southsouthwest of the northwestmost corner of 52 Dundas Street, Stromness, a total distance of one metre or thereby, as shown in grey on Plan 3.
- v) On the southeast, eastsoutheast and south sides of A965 Dundas Street, Stromness, from a point three hundred millimetres or thereby northwest of the southwestmost corner of 56 Dundas Street, Stromness, to a point two metres five hundred millimetres or thereby southsouthwest of the northwestmost corner of 2 Gray's Noust, Stromness, a total distance of fourteen metres or thereby, as shown in grey on Plan 3.
- w) On the southeast, southsoutheast and east sides of A965 Dundas Street, Stromness, from a point one metre or thereby northnortheast of the southwestmost corner of 2 Gray's Noust, Stromness, to a point two hundred millimetres or thereby southwest of the southwestmost corner of 78 Dundas Street, Stromness, a total distance of thirty six metres or thereby, as shown in grey on Plan 3.
- x) On the west, westnorthwest, northwest and northnorthwest sides of A965 Dundas Street, Stromness, from its junction with A965 Graham Place, Stromness, to its junction with unclassified Hellihole Road, Stromness, a total distance of one hundred and seventy three metres nine hundred millimetres or thereby, as shown in grey on Plan 3.
- y) On the east side of A965 Graham Place, Stromness, from its junction with A965 Victoria Street, Stromness, to a point five metres or thereby northnortheast of the southwestmost corner of the garden adjoining 6

Graham Place, Stromness, a distance of ten metres four hundred millimetres or thereby, as shown in grey on Plan 3.

- z) On the east side of A965 Graham Place, Stromness, from the southwestmost corner of the garden adjoining 6 Graham Place, Stromness, proceeding in a southerly direction for a distance of one metre or thereby, as shown in grey on Plan 3.
- aa) On the east and eastsoutheast sides of A965 Graham Place, Stromness, from a point at the westmost corner of the garden adjoining 10 Graham Place, Stromness, to its junction with A965 Dundas Street, Stromness, a total distance of twelve metres or thereby, as shown in grey on Plan 3.
- bb) On the northwest, west and southwest sides of A965 Graham Place, Stromness, from its junction with A965 Victoria Street, Stromness, to its junction with A965 Dundas Street, Stromness, a distance of forty three metres seven hundred millimetres or thereby, as shown in grey on Plan 3.
- cc) On the eastsoutheast, southeast and east sides of A965 Victoria Street, Stromness, from its junction with A965 John Street, Stromness, to its junction with A965 Graham Place, Stromness, a distance of three hundred and twenty four metres three hundred millimetres or thereby, as shown in grey on Plan 2 and Plan 3.
- dd) On the northwest side of A965 Victoria Street, Stromness, from its junction with A965 John Street, Stromness, to a point three metres or thereby southeast of the southeastmost corner of 5 – 9 Victoria Street Stromness, a distance of thirty nine metres three hundred millimetres or thereby, as shown in grey on Plan 2.
- ee) On the northwest side of A965 Victoria Street, Stromness, from a point eight metres or thereby southsouthwest of the northeastmost corner of the garden adjoining the Town House, Victoria Street, Stromness, to a point nine metres or thereby northeast of the southeastmost corner of the garden adjoining the Town House, Victoria Street, Stromness, a distance of thirteen metres or thereby, as shown in grey on Plan 2.
- ff) On the northwest and westnorthwest sides of A965 Victoria Street, Stromness, from a point four metres northeast of the southeastmost corner of the garden adjoining the Town House, Victoria Street, Stromness, to a point at the northeastmost corner of the Royal Hotel,

Victoria Street, Stromness, a total distance of ninety one metres eight hundred millimetres or thereby, as shown in grey on Plan 2 and Plan 3.

- gg) On the northwest and westnorthwest side of A965 Victoria Street, Stromness, from a point five metres or thereby southwest of the northeastmost corner of the Royal Hotel, Victoria Street, Stromness, to a point six metres or thereby southwest of the northeastmost corner of the Royal Hotel, Victoria Street, Stromness, a distance of one metre or thereby, as shown in grey on Plan 3.
- hh) On the westnorthwest side of A965 Victoria Street, Stromness, from a point at the southeastmost corner of the Royal Hotel, Victoria Street, Stromness, to its junction with unclassified Church Road, Stromness, a distance of thirty six metres seven hundred millimetres or thereby, as shown in grey on Plan 3.
- ii) On the westnorthwest side of A965 Victoria Street, Stromness, from its junction with unclassified Church Road, Stromness, to a point two metres eight hundred millimetres or thereby south of the southeastmost corner of 89 Victoria Street, Stromness, a distance of thirty two metres eight hundred millimetres or thereby, as shown in grey on Plan 3.
- jj) On the westnorthwest and northwest sides of A965 Victoria Street, Stromness, from a point one metre or thereby northnortheast of the northeastmost corner of 101 Victoria Street, Stromness, to a point one metre three hundred millimetres or thereby southwest of the southmost corner of 113 Victoria Street, Stromness, a total distance of twenty nine metres four hundred millimetres or thereby, as shown in grey on Plan 3.
- kk) On the northwest side of A965 Victoria Street, Stromness, from a point at the northeastmost corner of 1 Graham Place, Stromness, in a northwesterly direction for a distance of one metre nine hundred millimetres or thereby, as shown in grey on Plan 3.
- ll) On the east side of A965 John Street, Stromness, from the northwestmost corner of 40 John Street, Stromness, to a point three metres two hundred millimetres or thereby southsouthwest of the southwestmost corner of 40 John Street, Stromness, a distance of nine metres or thereby, as shown in grey on Plan 2.
- mm) On the southeast side of A965 John Street, Stromness, from a point at the northwestmost corner of the Gospel Hall, 36 John Street, Stromness, to a point three metres five hundred millimetres or thereby

southwest of the southwestmost corner of 24 John Street, Stromness, a distance of sixty four metres seven hundred millimetres or thereby, as shown in grey on Plan 2.

- nn) On the southeast side of A965 John Street, Stromness, from a point six metres or thereby southwest of the southwestmost corner of 24 John Street, Stromness, to a point seven metres five hundred millimetres or thereby southwest of the southwestmost corner of 24 John Street, Stromness, a distance of one metre five hundred millimetres or thereby, as shown in grey on Plan 2.
- oo) On the southeast side of A965 John Street, Stromness, from a point ten metres or thereby southwest of the southwestmost corner of 24 John Street, Stromness, to a point eleven metres five hundred millimetres or thereby southwest of the southwestmost corner of 24 John Street, Stromness, a distance of one metre five hundred millimetres or thereby, as shown in grey on Plan 2.
- pp) On the southeast side of A965 John Street, Stromness, from a point fourteen metres or thereby southwest of the southwestmost corner of 24 John Street, Stromness, to a point sixteen metres or thereby southwest of the southwestmost corner of 24 John Street, Stromness, a distance of two metres or thereby, as shown in grey on Plan 2.
- qq) On the eastsoutheast side of A965 John Street, Stromness, from a point at the northwestmost corner of the Ferry Inn, John Street, Stromness, in a northnortheasterly direction for a distance of two metres five hundred millimetres or thereby, as shown in grey on Plan 2.
- rr) On the eastsoutheast and east sides of A965 John Street, Stromness, from a point ten metres or thereby southsouthwest of the northwestmost corner of the Ferry Inn, John Street, Stromness, to its junction with A965 Victoria Street, Stromness, a distance of thirty four metres five hundred millimetres or thereby, as shown in grey on Plan 3.
- ss) On the westnorthwest side of A965 John Street, Stromness, from a point three metres or thereby southwest of the northeastmost corner of 87 John Street, Stromness, to a point six metres or thereby northnortheast of the northeastmost corner of 71-79 John Street, Stromness, a distance of fifty four metres or thereby, as shown in grey on Plan 2.
- tt) On the westnorthwest side of A965 John Street, from a point four metres or thereby southwest of the northeastmost corner of 71-79 John

Street, Stromness, to a point eight metres seven hundred millimetres or thereby northeast of the southeastmost corner of the said 71-79 John Street, Stromness, a distance of five metres eight hundred millimetres or thereby, as shown in grey on Plan 2.

- uu) On the westnorthwest and northwest sides of A965 John Street, Stromness, from a point two metres six hundred millimetres or thereby southeast from the southeastmost corner of 71-79 John Street, Stromness, to its junction with A965 Victoria Street, Stromness, a total distance of one hundred and nine metres five hundred millimetres or thereby, as shown in grey on Plan 2.
- vv) On the east and southeast sides of A965 North End Road, Stromness, from the northwestmost corner of 40 John Street, Stromness, to a point three metres or thereby northwest of the southwestmost corner of 12 North End Road, Stromness, a distance of one hundred and twenty three metres or thereby, as shown partly in grey and partly in orange on Plan 1 and Plan 2.
- ww) On the east and northeast sides of A965 North End Road, Stromness, from a point six metres or thereby northwest from the southwestmost corner of 16 North End Road, Stromness, to the northwestmost corner of 16 North End Road, Stromness, a distance of seven metres or thereby, as shown in orange on Plan 1.
- xx) On the east and northeast sides of A965 North End Road, Stromness, from the southwestmost corner of the garden adjoining 22 North End Road, Stromness, to a point four metres or thereby northeast of the southwestmost corner of the garden adjoining 22 North End Road, Stromness, a distance of four metres or thereby, as shown in orange on Plan 1.
- yy) On the east and northeast sides of A965 North End Road, Stromness, from a point nineteen metres or thereby northnortheast from the southwestmost corner of the garden adjoining 22 North End Road, Stromness, to a point six metres six hundred millimetres or thereby southsouthwest of the northwestmost corner of the garden adjoining 22 North End Road, Stromness, a distance of eight metres or thereby, as shown in orange on Plan 1.
- zz) On the east and northeast sides of A965 North End Road, Stromness, from a point one metre six hundred millimetres or thereby southsouthwest of the northwestmost corner of the garden adjoining 22 North End Road, Stromness, to a point twenty metres or thereby

southwest of the southwestmost corner of 30 North End Road, Stromness, a distance of twelve metres five hundred millimetres or thereby, as shown in orange on Plan 1.

- aaa) On the northeast side of A965 North End Road, Stromness from a point six metres three hundred millimetres or thereby southsouthwest of the southwestmost corner of 30 North End Road, Stromness, to the southwestmost corner of 30 North End Road, Stromness, a distance of six metres three hundred millimetres or thereby, as shown in orange on Plan 1.
- bbb) On the northeast side of A965 North End Road, Stromness, from the northwestmost corner of 34 North End Road, Stromness, to the northwestmost corner of the garden adjoining 34 North End Road, Stromness, a distance of nineteen metres four hundred millimetres or thereby, as shown in orange on Plan 1.
- ccc) On the northnortheast side of A965 North End Road, Stromness, from the south side of the entrance to the North End Garage Fuel Station, Stromness, proceeding in a southerly direction for a distance of twelve metres or thereby, as shown in orange on Plan 1.
- ddd) On the westnorthwest side of A965 North End Road, Stromness, from a point fifteen metres northeast from the northeastmost corner of the Fire Station, North End Road, Stromness, proceeding in a southsouthwesterly direction to its junction with the north side of the entrance to Blue Star Garage, North End Road, Stromness, a distance of one hundred and thirty two metres seven hundred millimetres or thereby, as shown in orange on Plan 1.
- eee) On the west and southwest sides of A965 North End Road, Stromness, from a point three metres or thereby eastnortheast of the southeastmost corner of 5 – 7 North End Road, Stromness, proceeding firstly in a southerly and thereafter in a southwesterly direction on the north side of C43 Back Road, Stromness, to a point at the northeastmost corner of Bellevue, Back Road, Stromness, a distance of ninety nine metres five hundred millimetres or thereby, as shown in orange on Plan 1 and then on Plan 2.
